EC2000-339

HEALTH SERVICES PAYMENT ACT REGULATIONS **AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 13 June 2000.)

Pursuant to section 5 of the Health Services Payment Act R.S.P.E.I. 1988, Cap. H-2, Council made the following regulations:

- 1. Section 37 of the Health Services Payment Act Regulations (EC453/96) is revoked and the following substituted:
- 37. (1) Anaesthetic and other hospital costs associated with dental Hospital and other services provided in a hospital by a practitioner

- (a) that are listed in Schedule A or B, are covered under the Plan; and
- (b) that are not listed in Schedule A or B, are not covered under the Plan unless the dental services have the prior approval of the Minister.
- (2) For the purposes of subsection (1), practitioner means an oral Practitioner maxillofascial surgeon.
- 2. Schedule A of the Regulations is amended by the revocation of the following words "1. Surgical removal of impacted teeth;".
- 3. These regulations come into force on June 13, 2000.

EXPLANATORY NOTES

The amendments allows for anaesthetic and other hospital costs to be covered for procedures performed by an oral maxillofascial surgeon and listed in Schedule A or B.
