CONSENT TO TREATMENT AND HEALTH CARE **DIRECTIVES ACT** REGULATIONS

(Approved by His Honour the Lieutenant Governor in Council dated 20 June 2000.)

Pursuant to section 36 of the Consent to Treatment and Health Care Directives Act Stats. P.E.I. 1996, c.10, Council made the following regulations:

1. In these regulations

Definitions

(a) "approved assessment tool" means a clinical aid approved by the approved Minister that is designed to evaluate capacity;

(b) "approved training" means a program of training, approved by approved training the Minister, in capacity assessment using the approved assessment tool.

- 2. An approved assessment tool
 - (a) may be used in conducting an assessment of capacity pursuant to tool section 7 of the Act; and
 - (b) shall be used in conducting a reassessment of capacity pursuant to section 9 of the Act.
- 3. (1) Subject to subsection (2), a finding of incapacity made pursuant to Written finding of section 7 of the Act shall be recorded in writing.

- (2) Form A of the attached Schedule A
 - (a) may be used to record a finding of incapacity pursuant to section 7 of the Act, where there is no request for reassessment pursuant to section 9 of the Act; and

- **4.** (1) A health practitioner who has successfully completed the approved who conducts training may conduct a reassessment pursuant to section 9 of the Act.

 - (iii) have together entered into a cohabitation agreement under section 52 of the Family Law Act R.S.P.E.I. 1988, Cap. F-2
- 4. Son, daughter, or parent; or a person who has assumed parental authority and who is lawfully entitled to give or refuse consent to treatment on the person's behalf
- Brother or sister
- 6. Trusted friend
- 7. Other relative
- 8. Public Guardian If no one listed above is available*, capable, and willing to assume responsibility for making a decision, or if there is disagreement among persons of the same class (subsection 11(6))
- *Available subsection 11(7) of the Act states a person is available if it is possible for the health practitioner, within a time that is reasonable in the circumstances, to communicate with the person and obtain a decision.

EXPLANATORY NOTES

These regulations specify the assessment tool used in determining capacity, who may reassess capacity, prescribe forms for finding incapacity, and provide an optional form for an agreement to act as a substitute decision maker.

HOSPITALS ACT

HOSPITAL MANAGEMENT REGULATIONS **AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 20 June 2000.)

Pursuant to 14 of the Hospitals Act R.S.P.E.I. 1988, Cap. H-10, Council made the following regulations:

1. Section 48 of the Hospital Management Regulations (EC574/76) is revoked and the following substituted:

48. (1) No surgical treatment shall be performed on a patient unless a Consent for surgical consent in writing for the surgical treatment is signed, in accordance with treatment the Consent to Treatment and Health Care Directives Act, Stats. P.E.I. 1996, c.10, by

- (a) the patient; or
- (b) a substitute decision-maker pursuant to section 11 of that Act.
- (2) Notwithstanding subsection (1), and subject to subsection (3), Surgical treatment surgical treatment may be performed without the consent required by subsection (1), where treatment without consent is permitted pursuant to section 16 or 17 of the Consent to Treatment and Health Care Directives Act.

without consent

(3) No surgical treatment shall be performed pursuant to subsection (2) Refusal of consent where the patient has refused the surgical treatment, as evidenced by the most recent health care directive made by the patient in accordance with the Consent to Treatment and Health Care Directives Act.

2. These regulations come into force on July 1, 2000.

EXPLANATORY NOTES

This regulation replaces the former rules regarding consent for surgical operations. The changes synchronize the consent requirements of the Hospital Management Regulations with the consent requirements of the Consent to Treatment and Health Care Directives Act.

PRINCE EDWARD ISLAND LANDS PROTECTION ACT EXEMPTION REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 22 June 2000.)

Pursuant to clause 17(1)(b) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council made the following regulations:

1. The Prince Edward Island Lands Protection Act Exemption Regulations (EC368/88) are amended by the addition of the following:

J.D. Irving Limited

- **23.** (1) The following properties being acquired by J.D. Irving Limited, located in Georgetown Royalty and totalling approximately 105.62 acres, are exempt from the application of the Act:
 - (a) approximately 29.36 acres, being Provincial Property Number 730036:
 - (b) approximately 8.00 acres, being Provincial Property Number 730044;
 - (c) approximately 60.26 acres, being Provincial Property Number 820258;
 - (d) approximately 8.00 acres, being Provincial Property Number 878348.

Prohibition

(2) No person shall subdivide any of the real properties listed in subsection (1).

(3) The prohibition against subdivision established by subsection (2) is binding on J.D. Irving Limited and all successors in title.

Subsection (2) binding

2. These regulations come into force on June 30, 2000.

EXPLANATORY NOTES

These regulations exempt the properties listed from the provisions of the Prince Edward Island Lands Protection Act.
