AMENDMENTS TO LEGAL PROFESSION ACT REGULATIONS

Pursuant to Section 55 of the *Legal Profession Act*, S.P.E.I. 1992, Cap. 39, the Law Society of Prince Edward Island approved the following amendments to the *Legal Profession Act Regulations* at its Annual Meeting on June 24, 2000.

Regulation 36(1)(j)

Delete all after (j) "trust money" means" and

- **Insert** "(i) money received by a member in connection with the practice of law in the Province that belongs in whole or in part to a client or another person or that is received on the client's behalf or to the direction or order of the client or another person;
 - (ii) money advanced to a member on account of fees for services not yet rendered or money advanced on account of disbursements not yet made;
 - (iii) money and other valuable property over which the member has sole signing authority or control in the capacity of executor, administrator, coexecutor, co-administrator, proctor of an estate, sole trustee or co- trustee of an inter vivos or testamentary trust, guardian or as attorney under a power of attorney."

Regulations 36D (new)

" (1) The provision of Regulations 36A, 36B and 36C do not apply to monies referred to in paragraphs (i) and (iii) of sub-regulation 36(1)(j) where:

(i) the member has sole signing authority or control in the capacity of executor or administrator over funds of a deceased person, and the total value of the assets under the member's authority or control during the member's annual Form 7 reporting period in relation to the deceased person's estate equals \$20,000 or less; or

(ii) all or substantially all of the trust money is used or disbursed for, or paid to persons in the member's own family as defined in sub-regulation 36D(2), and the persons in the family of the member have provided in the prescribed form, written waivers and certificates of independent legal advice to the effect that the monies do not need to be held in accordance with Regulations 36A, 36B and 36C.

(2) For the purpose of this Regulation, 'family' means spouses, including common-law and same sex partners, and those related to the member by consanguinity or adoption.

(3) The effect of signing the written consent referred to in sub-regulation 36D(l)(ii) is that the person in the member's family waives the protections provided by Regulations 36(A), 36(B) and 36(C) as well as any protection provided by the reimbursement fund.

(4) For greater certainty, a waiver and certificate referred to in sub-regulation 36(D)(ii) must be given by a person who is of the age of majority and competent to sign a waiver or certificate and, where a guardian has been appointed for a person, that guardian may give or sign a waiver or certificate."

Regulation 37(8)

delete all after "they may think appropriate and deliver" **insert** "to the Secretary Treasurer with a report indicating the significance of the non-compliance in each case"

Regulation 37(9)

delete entire sub-section

insert "Upon receipt of the report described in sub-section (8), the Secretary Treasurer may order the audit of the books, records and accounts of any firm which the Society's Auditors indicate are in non-compliance with Section 44 of the Act or this regulation."

Regulation 37(10)

delete entirely

insert "In addition to the audits which may be ordered in accordance with sub-section (9), the Secretary Treasurer may order the audit of the books, records and accounts of any practising, insured member selected on a random basis."

Insert the following **new** Regulation:

Regulation 37(11)

"A member audited pursuant to sub-section (10), will not be subject to audit under that sub-section for a period of 3 years following the date on which the audit was carried out."

Regulation 37(12)

"Failure to cooperate with an audit being carried out under sub-sections (9) or (10) will constitute unprofessional conduct and will be subject to discipline in accordance with sub-section 37(1)(b) of the Act."

Regulation 37(13)

"Audits ordered under sub-sections (9) or (10) will be carried out by a Chartered Accountant who will execute an undertaking to maintain the confidentiality of client information."

Regulation 37(14)

"The report of an audit carried out pursuant to sub-sections (9) or (10) will be forwarded to the member or firm which was the subject of the audit, and to the Secretary Treasurer."

Regulation 37(15)

"On receipt of the report of an audit carried out in accordance sub-section (9) or (10), the Secretary Treasurer may make a report to the Chair of a discipline committee who shall determine whether an investigation should be initiated under section 26 of these regulations."
