- Residential deposits the rate prevailing on Government of Canada one year Treasury Bills; and
- General Service and Industrial deposits the rate prevailing on three year Government of Canada Bonds.

Interest on all cash security deposits is compounded semi-annually as long as any portion of the deposit remains.

Residential, General Service and Industrial accounts are reviewed periodically and deposits will be refunded as a credit to the account for which the deposit was held if the Customer deposits are reviewed twelve months after a deposit is made, General and Industrial Customer deposits are reviewed thirty-six months after a deposit is made. If a satisfactory payment history has not been established then a security deposit extension may be required. Interest on security deposit extensions is calculated at the interest rate prevailing at the time of the extension.
