**EC2001-61**

**ENVIRONMENTAL PROTECTION ACT**  
**OZONE DEPLETING SUBSTANCES AND REPLACEMENT**  
**REGULATIONS**  
**AMENDMENT**

(Approved by the Administrator in Council dated 6 February 2001.)

Pursuant to section 25 of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, Council made the following regulations:

**1. Section 1 of the *Environmental Protection Act Ozone Depleting Substances and Replacement Regulations* (EC619/94) is amended**

**(a) by the revocation of clause (c) and the substitution of the following:**

(c) "approved cylinder" means a refillable pressurized container that is designed specifically for containing regulated substances with a total capacity of 10 kilograms or greater and which meets the requirements of the *Transportation of Dangerous Goods Regulations* made pursuant to the *Transportation of Dangerous Goods Act* (Canada); approved cylinder

**(b) by the revocation of clause (e) and the substitution of the following:**

(e) "Code of Practice" means the most recent version of the Code of Practice for the Elimination of Fluorocarbon Emissions from Refrigeration and Air Conditioning Systems published by Environment Canada as amended; Code of Practice

**2. Section 2 of the regulations is amended by the addition of the following clause:**

(c) a Category III substance classified in Schedule A as a Perfluorocarbon.

**3. Section 3 of the regulations is amended**

(a) in subsection (1), by the deletion of the words “Subject to section 12 and subsection (2)” and the substitution of the words “Except as permitted by section 12 and subsection (2)”;

(b) by the revocation of subsection (2) and the substitution of the following:

Centrifugal chillers (2) Effective June 30, 2001, every sub-atmospheric centrifugal chiller shall have a chiller system purge unit designed to expel no more than 0.1 grams of a regulated substance for every gram of air that is purged.

**4. Clause 4(a) of the regulations is amended by the deletion of the words “20 kg” and the substitution of the words “10 kg”.**

**5. Section 7 of the regulations is amended**

(a) in subsection (1), by the deletion of the words “Effective December 15, 1994 no” and the substitution of the word “No”;

(b) by the deletion of clause (2)(a) and the substitution of the following:

(a) servicing air conditioning equipment, refrigeration equipment, or fire extinguishing equipment; or

**6. Subsection 8(6) of the regulations is amended by the deletion of the words “Effective December 15, 1994 no” and the substitution of the word “No”.**

**7. Subsection 9(1) of the regulations is revoked and the following substituted:**

Automobile air conditioning

(1) No person shall

(a) service a motor vehicle air conditioner except in the manner set out in the Code of Practice and the Society of Automotive Engineers (SAE) Standard J-2219; or

(b) replace the refrigerant in a motor vehicle system with a flammable or ignitable substance or mixture or a Category I substance.

**8. Section 13 of the regulations is amended****(a) by the revocation of subsection (1) and the substitution of the following:**

(1) Effective June 30, 2001, no person or company shall purchase, offer for sale, sell, or supply a regulated substance intended for the purposes of charging air conditioning or refrigeration equipment, except where the person or company has a valid license to purchase a regulated substance in accordance with this section. Sales, etc. of  
regulated substances

**(b) by the revocation of subsection (3) and the substitution of the following:**

(3) To obtain a license pursuant to this section, a person or company shall License

- (a) submit a completed application form; and
- (b) pay a fee of \$100 to the Provincial Treasurer.

**(c) by the revocation of subsection (4);****(d) by the revocation of subsection (7) and the substitution of the following:**

(7) Where the Department is satisfied that a person or company has Renewal of license  
(a) complied with any terms and conditions imposed on the person or company pursuant to subsection (5); and  
(b) paid a renewal fee of \$100 to the Provincial Treasurer  
the Department shall renew the person or company's license issued pursuant to this section.

**9. Subsection 14(1) of the regulations is amended by the deletion of the words "No person" and the substitution of the words "Effective six months after the date these regulations come into force, no person".**

**10. Section 17 of the regulations is amended**

**(a) in subsections (1), (2), and (4), by the deletion of the words "On or after January 1, 1995, no" wherever they occur and the substitution of the word "No";**

**(b) in subsection (5), by the deletion of the words "On or after January 1, 1996, no" and the substitution of the word "No".**



**11. Schedule A is amended by the addition of the following:**

CATEGORY III	PERFLUOROCARBONS (PFC's)
(1) FC-14	known as tetrafluoromethane
FC-116	known as hexafluoroethane
FC-218	known as octafluoropropane
FC-3-10	known as decafluorobutane
FC-4-1-12	known as dodecafluoropentane
FC-5-1-4	known as tetradecafluorohexane
(2)	All other perfluorocarbons not specifically listed above.
(3)	All isomers and mixtures containing any other substance listed in this Schedule.

**12. These regulations come into force on February 17, 2001.****EXPLANATORY NOTES**

These amendments are necessary to comply with the "National Action Plan for Recovery, Recycling and Reclamation of CFC's" developed by the Canadian Council of Ministers of the Environment to address the issue of ozone depletion.
