- (c) a semi-detached commercial development may be located on a lot subdivided for individual sale or ownership provided that,
 - (i) construction of the common wall complies with the Fire Prevention Act R.S.P.E.I. 1988 Cap. F-11, and
 - (ii) each unit is located on a lot that complies with the regulations.

3. These regulations come into force on April 7, 2001.

EXPLANATORY NOTES

The amendments add the term "semi-detached commercial development" and specify where this type of development is permissible.
