VITAL STATISTICS ACT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 10 April 2001.)

Pursuant to section 40 of the *Vital Statistics Act* R.S.P.E.I. 1988 Cap. V-4.1, Council made the following regulations:

1. Subsection 7(1) of the $\it Vital Statistics Act Regulations (EC453/00)$ is amended

- (a) in clause (f) by the deletion of the words "\$20" and the substitution of the words "\$25";
- (b) in clause (g) by the deletion of the words "\$30" and the substitution of the words "\$35";
- (c) in clause (h) by the deletion of the words "\$20" and the substitution of the words "\$25";
- (d) in clause (i) by the deletion of the words "\$30" and the substitution of the words "\$35";
- (e) by the addition of the following:
- (p) rush certificates (out of province) \$25
- (q) change of name notification (out of province) \$25
- 2. These regulations come into force on April 30, 2001.
