NOW KNOW YE that We, by and with the advice and consent of our Executive Council for Prince Edward Island, do by this Our Proclamation ORDER AND DECLARE that the said Act, being "An Act to Amend the Consent to Treatment and Health Care Directives Act", passed in the forty-ninth year of Our Reign, shall be deemed to have come into force on the first day of January, two thousand and one of which all persons concerned are to take notice and govern themselves accordingly.

ROADS ACT
HIGHWAY ACCESS REGULATIONS
AMENDMENT

(Approved by the Administrator in Council dated 7 August 2001.)

Pursuant to section 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

1. Clause 1(1)(a) of the Highway Access Regulations (EC580/95) is amended by the deletion of the words “the change in use of a parcel of land” and by the substitution of the words “, in respect of a parcel of land, the change in use of the parcel of land”.

2. Section 3 of the regulations is amended by the deletion of the words “arterial” and by the substitution of the words “arterial highway, limited access arterial highway”.

3. Subsection 9(2) of the regulations is amended by the deletion of the words “costs for” and by the substitution of the words “the costs, or any portion of the costs of any changes to a highway that are associated with the construction or change of use of”.

4. Section 24 of the regulations is revoked and the following substituted:

24. No entrance way permit shall be issued for the construction of an entrance way opening onto a limited access arterial highway, unless Restriction

- (a) the application for the entrance way permit is in respect of the relocation of an existing entrance way; and
- (b) the Minister has determined that the issuance of the entrance way permit would be in the best interest of the province.

5. Item 1(1) of Schedule A-2 of the regulations is amended by the deletion of the words “Garfield Street” and by the substitution of the words “Grafton Street”.

6. These regulations come into force on August 18, 2001.

EXPLANATORY NOTES

The amendments will enable the Department of Transportation and Public Works to control the use of the existing entrance ways on this segment of the Charlottetown Perimeter Highway which was not previously included in the Highway Access Regulations.
