ENVIRONMENTAL PROTECTION ACT HARBOUR LAND AND WATER ENVIRONMENTAL MANAGEMENT, PROTECTION AND ENHANCEMENT POLICY

Pursuant to subsection 3(1) of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, Council endorsed the adoption of the following policy by the Minister effective October 30, 2001:

Definition

- 1. In this policy,
 - (a) "harbour land" means
 - (i) any land, including land covered by water, in the public harbours of Charlottetown, Georgetown, Souris or Summerside, and
 - (ii) any parcel of land immediately adjoining land referred to in clause (a):
 - (b) "harbour water" means the water body of the public harbours of Charlottetown, Georgetown, Souris or Summerside.

General

- (1) It is the policy of this province to promote the protection and enhancement of the environment in respect of harbour land and harbour water.
 - (2) It is the policy of this province, in the administration of the Act and the regulations,
 - (a) to encourage respect for, and education concerning, the importance of harbour land and harbour water;
 - (b) to minimize the release and accumulation of contaminants in or on harbour land or harbour water;
 - (c) to cause the removal of contaminants in or on harbour land or harbour water;
 - (d) to minimize the disturbance or degradation of the environment in

respect of harbour land and harbour water; and

(e) to minimize the danger to human life or health or of damage to property arising out of exposure to contaminants in or on harbour land or harbour water.

Inspections

3. It is the policy of the province that harbour land and harbour water will be inspected, by environment officers under the Act, for the purposes set out in this policy,

(a) on the transfer of the ownership of any harbour land or harbour water;

(b) on the filing of a proposal for the Minister's approval to proceed with a proposed undertaking;

(c) on or before any change in use of any harbour land or harbour water that may, in the opinion of the Minister, cause contamination of the environment; and (d) on or before any development of any harbour land that may, in the opinion of the Minister, cause contamination of the environment.

PRINCE EDWARD ISLAND LANDS PROTECTION ACT HARBOUR LAND ACQUISITION POLICY

Pursuant to subsection 8(2) and section 8.1 of the *Prince Edward Island Lands Protection Act*, R.S.P.E.I. 1988, Cap. L-5, Council adopted the following policy effective October 30, 2001:

Definition

1. In this policy, "harbour land" means

(a) any land, including land covered by water, in the public harbours of Charlottetown, Georgetown, Souris or Summerside, and

(b) any parcel of land immediately adjoining land referred to in clause (a).

General Intent and Objective

2. The general intent of this policy is to promote the protection of the economic and cultural needs of the people of the province in respect of the review of applications made under the Act for permission to acquire harbour lands.

Matters to be Considered

3. (1) It is the policy of the province that recommendations made by the Commission under subsection 8(1) of the Act in respect

of an application for permission to acquire harbour land shall be based on the consideration of the following matters, in addition to those set out in subsection 8(2) of the Act:

(a) the impact or potential impact of any proposed acquisition on public access to a public harbour;

(b) the impact or potential impact of any proposed acquisition on the marine transportation system of the province;

(c) the impact or potential impact of any proposed acquisition on the businesses of and business opportunities for residents, including businesses and business opportunities respecting the tourist industry;

(d) the impact or potential impact of any proposed acquisition on recreational activities;

(e) the impact or potential impact of any proposed use of the relevant harbour land after its acquisition, including any subsequent potential requirement for, and the liabilities and costs that may arise from, the removal of any environmental contaminants existing in or on that harbour land:

(f) the current or future need for, and the current or future liabilities and costs in respect of, the removal of any environmental contaminants existing in or on the harbour land.

(2) When considering a matter referred to in clauses (1)(a) to (d) and (f), the Commission shall also consider the proposed use that the applicant intends to make of the harbour land.
