EC2002-26

ADOPTION ACT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 22 January 2002.)

Pursuant to section 57 of the Adoption Act R.S.P.E.I. 1988, Cap. A-4.1, Council made the following regulations:

1. Section 6 of the Adoption Act Regulations (EC526/93) is revoked and the following substituted:

6. (1) Subject to section 10, the Director may issue a license in Form 2 License (License to Arrange Adoption Placements) to an applicant who meets the requirements of section 2 and pays the prescribed fee.

(2) The Director shall consider the following factors when assessing Factors applications for a license under this section:

(a) the number of adoption agents, if any, serving the geographical area in which the applicant proposes to provide an adoption placement service; and

(b) the need for adoption services in the geographical area proposed to be served.

(3) Notwithstanding any other provision of these regulations, the Director's discretion Director may refuse to issue a license or limit the number of licenses issued pursuant to this section.

2. The regulations are amended by the revocation of clause 89(1)(c).

3. These regulations come into force on February 2, 2002.

EXPLANATORY NOTES

These regulations give discretion to the Director of Child Welfare in determining whether to issue adoption agent licenses and the number of licenses to issue. A reference to fees that are no longer applicable is deleted.
