AMENDMENTS TO LEGAL PROFESSION ACT REGULATIONS

Pursuant to Section 55 of the *Legal Profession Act*, S.P.E.I. 1992, Cap.39, the Law Society of Prince Edward Island approved the following amendments to the *Legal Profession Act Regulations* at the MidWinter Meeting of the Society held on February 2, 2002.

A. <u>Regulation 18 (d)</u> is amended by inserting the words "or has been allowed to resign by Council on the recommendation of a discipline committee" after the words "... roll of members."

Regulation 18(e) is added which reads as follows:

- 18(e) if conditions have been placed on a person's re-admission by Council, on recommendation of a discipline committee, must establish to Council's satisfaction that the conditions have been or will be met.
- B. *Regulation 37(2)* is amended as follows:
 - delete "referring ...year"
 delete "that fiscal year"
 insert "the preceding twelve months"
 add after "has" "or has"
 delete "money in trust"
 insert "trust money"
 delete "which ... Regulations"

Section 37(2) now will read:

37(2) A statutory declaration in Form 6 shall be filed by each member declaring that during the preceding twelve months the member has or has not received any trust money.

Regulations 37(3) to (6) are amended as follows:

- 37(3) delete section entirely and replace with:
 - 37(3) Each firm which is subject to a review pursuant to Regulation 37A will be required to complete a Form 17 upon receiving notice of the review.
- 37(4) insert new section
 - 37(4) All firms which have not been reviewed pursuant to Regulation 37A during the twelve months preceding July 1 of each year shall file a completed Form 17 with the Secretary-Treasurer prior to that date.
- 37(5) re-number old 37(4) to be new section 37(5)
- 37(6) re-number old section 37(5) to be new section 37(6) delete "(3)" and insert "(4)"
