1. Subsection 15(3) of the *Gasoline Tax Act* Regulations (EC283/72) is amended by the revocation of clause (b) and the substitution of the following:

- (b) for furnishing power for boats only when the boats are being used by fishermen in the practice of fishing;
- (b.1) for furnishing power for boats and equipment only when the boats and equipment are being used by aquaculturists in the practice of aquaculture;

2. These regulations come into force on April 20, 2002.

EXPLANATORY NOTES

This amendment revokes the current clause 15(3)(b) and replaces it with two separate clauses.
