EC2002-124

ADOPTION ACT SUPPORTED ADOPTION REGULATIONS

(Approved by His Honour the Lieutenant Governor in Council dated 12 March 2002.)

Pursuant to section 57 of the Adoption Act R.S.P.E.I. 1988, Cap. A-4.1, Council made the following regulations:

1. In these regulations

Definitions

(a) "adoption support agreement" means an agreement, referred to in adoption support section 56 of the Act, between the Director and the adoptive parents agreement of a child that provides for assistance in respect of the adoption of the child and that is entered into, or designated as such an agreement, in accordance with these regulations;

- (b) "adoptive parents", in respect of a child, includes proposed adoptive parents adoptive parents of the child;
- (c) "assistance" means assistance provided to adoptive parents, in assistance accordance with these regulations, and includes
 - (i) a maintenance payment, and
 - (ii) special support;
- (d) "maintenance payment" means a payment for the ongoing basic maintenance needs of a child;

(e) "special need" means a special need of a child identified by the special need Director under subclause 2(1)(a)(i);

(f) "special support" means support, in any form, for a special need special support of a child and includes, but is not limited to, the payment or provision of the following:

- (i) medical expenses,
- (ii) home renovations to accommodate an identified need,
- (iii) equipment determined by the Director to be necessary for the child,
- (iv) counselling or therapy, including psychological, occupational, play, speech or hearing therapy,
- (v) remedial education,
- (vi) rehabilitation therapy,
- (vii) extraordinary transportation costs,
- (viii) respite care,

- (ix) adoption support and information services,
- (x) parenting programs or other training, or
- (xi) any other expenses related to care and treatment;

region

(g) "region" means an area of the province over which a regional authority has jurisdiction;

regional authority

(h) "regional authority" means a regional authority established pursuant to the *Health and Community Services Act* R.S.P.E.I. 1988, Cap. H-1.1;

Adoption support agreement

- **2.** (1) The Director may enter into an adoption support agreement with adoptive parents where the child to be adopted is under the age of 18 years, is in the permanent custody and guardianship of the Director and
 - (a) in the opinion of the Director,
 - (i) the child has one or more special needs because of a mental or physical disability, a serious attachment issue or an emotional or behavioural issue that significantly impedes the normal development of the child, or
 - (ii) the child is at risk of developing any of the disabilities or issues listed in subclause (i) due to a history of abuse, neglect, multiple placements, prenatal risks or has a parent with a known genetic illness; or
 - (b) is part of a sibling group being placed in the same family, or has a positive emotional tie of significant duration to the adoptive parents.

Assessment documentation

(2) For the purposes of subclauses (1)(a)(i) and (ii), the Director shall assess and document the assessment of the child's level of present or potential needs and the level of care required by the child.

Document facts

(3) For the purposes of subclause (1)(b), the Director shall document the facts of the child's sibling relationships and emotional ties.

Signing prior to adoption

(4) An adoption support agreement, other than one referred to in subsection 5(2), shall be signed by the parties before the making of a final order for the adoption of the child.

Service delivery

(5) Before an adoption support agreement is signed by the Director and the adoptive parents, the Director shall attach to the agreement a memorandum of understanding between the Director and the appropriate regional authority specifying the forms of assistance to be delivered by the regional authority to the family.

Maintenance payments

- **3.** Maintenance payments to adoptive parents
 - (a) shall not be paid unless the Director is satisfied that care for the child will place an undue financial burden on the family, as determined in accordance with the policies and procedures established by the Director; and

- (b) shall not exceed the basic Children in Care rate or equivalent rates established by policies of the Director.
- **4.** (1) Special support may be provided to adoptive parents in respect of Special support a special need of the child only to the extent to which comparable support is not available from another source, that the Director considers appropriate, without charge to the adoptive parent.

(2) The cost of any special support provided to adoptive parents shall Not to exceed not exceed the cost of the services or support that the child would be children in care eligible for if the child were in the care of the Director.

(3) Adoptive parents shall provide an accounting to the Director for Accounting by assistance received pursuant to these regulations, in accordance with the policies and procedures established by the Director.

(4) The prior approval of the Director is required respecting an *Idem* expenditure by the adoptive parents for which special support is claimed. and the adoptive parents shall provide written estimates of the expenditure, as directed by the Director.

(5) The Director may withhold, suspend or disallow future payments Penalty for failure or require repayment of sums paid under these regulations where to account adoptive parents fail to comply with subsection (3).

5. (1) If, prior to an adoption, no assistance has been identified as being Agreement for required by the Director or requested by the adoptive parents, the future support Director may enter into an adoption support agreement with the adoptive parents that provides for assistance at a later time on the basis of the assessed needs of the child

(2) The Director may designate as an adoption support agreement any Designated agreement referred to in section 56 of the Act that was entered into prior to the coming into force of these regulations.

6. (1) All adoption support agreements made pursuant to these Subject to review regulations shall be subject, at least every two years, to review by, and to every 2 years the approval of, the Director.

(2) After a review pursuant to subsection (1), the Director may revise Revision any terms and conditions of an adoption support agreement as the Director may consider appropriate.

(3) Notwithstanding anything to the contrary in these regulations or in Suspension of an adoption support agreement, the provision of assistance pursuant to the adoption support agreement may be suspended for any time periods during which the child does not reside with an adoptive parent.

7. (1) The provision of assistance under an adoption support agreement agreement terminates on the earlier of

Termination of

- (a) the day that the child reaches the age of 18;
- (b) the day the child leaves the care of the adoptive parents;
- (c) the day the child dies;
- (d) the day determined by mutual agreement of the Director and the adoptive parents; or
- (e) the day the child moves to another country.

Extension to age 21

(2) Notwithstanding clause (1)(a), the Director may extend assistance under an adoption support agreement until the child reaches the age of 21 if the Director considers it necessary and important in terms of the best interests of the child.

New agreement for child out of country (3) Notwithstanding clause (1)(e), where an adoptive parent and the child move to another country, the Director may extend assistance under the adoption support agreement if the Director considers it necessary and important in terms of the best interests of the child.

Family moves to another region

(4) Where an adoptive parent and the child move from one region in the province to another region, the regional authority which signed the memorandum referred to in subsection 2(5) shall continue to fund the assistance that was to be delivered under the memorandum, unless the regional authorities from the two regions agree to divide responsibility for the provision of that assistance.

Family moves to another province or territory

(5) For greater certainty, the provision of assistance under an adoption support agreement is not terminated by reason of the fact that an adoptive parent and the child have moved to another province or to a territory.

Effective date

8. These regulations come into force on November 1, 2002.

EXPLANATORY NOTES

SECTION 1 is the definition section.

SECTION 2 allows the Director to provide assistance to adoptive parents where certain criteria are met, requires that an adoption support agreement be signed by the parents and the Director, and a memorandum of understanding between the Director and the regional authority specifying services to be delivered is attached to the agreement.

SECTION 3 requires that eligibility requirements and policies of the Director apply to maintenance paid under the program and ensures that payments not exceed care costs that would be payable if the child were in the care of the Director.

SECTION 4 provides for assistance for special support and requires adoptive parents to account for the money.

SECTION 5 allows the Director to designate adoption support agreements made prior to these regulations as adoption support agreements.

SECTION 6 provides for review of adoption support agreements, revision of terms and conditions, and suspension of payments under adoption support agreements where the child does not live with an adoptive parent.

SECTION 7 sets out the circumstances in which an adoption support agreement may be terminated and when it can be extended beyond the child's 18th birthday, and allows the Director to continue an agreement where a parent moves with the child to another country. The section also addresses a move by the family to another region.

OFF-HIGHWAY VEHICLE ACT REGULATIONS **AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 16 April 2002.)

Pursuant to section 22 of the Off-Highway Vehicle Act R.S.P.E.I. 1988, Cap. O-3, Council made the following regulations:

1. Section 12 of the Off-Highway Vehicle Act Regulations (EC96/88) is revoked and the following substituted:

12. (1) No person who is the owner or operator of a snowmobile shall Age requirements permit it to be operated by a person under 14 years of age, unless the person is directly supervised by an adult who holds a valid driver's license.

- (2) No person who is the owner or operator of an off-highway vehicle, *Idem* other than a snowmobile, shall permit it to be operated by
 - (a) a person between 10 and 14 years of age, unless the person is directly supervised by an adult who holds a valid driver's license; or (b) a person less than 10 years of age.
- 2. These regulations come into force on April 27, 2002.

EXPLANATORY NOTES

The amendment deals with the minimum age requirements for the operation of off-highway vehicles.
