CIVIL SERVICE ACT
REGULATIONS
AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 23 April 2002.)

Pursuant to section 6.1 of the *Civil Service Act* R.S.P.E.I. 1988, Cap. C-8, Council approved the following regulations made by the Civil Service Commission:

1. The *Civil Service Act* Regulations (EC709/83) are amended by the deletion of the word “Board” wherever it appears and the substitution of the word “Commission”.

2. Section 11 of the regulations is amended

(a) by the revocation of subsection (1) and the substitution of the following:

(1) Subject to subsection (2), the appointment of every person entering the classified division, except provisional employees, shall be a probationary appointment until the person has performed 1000 hours of work in the position to which the person is appointed. Probation

(b) in subsection (2) by the deletion of the words “twelve months.” and the substitution of the words “1000 hours of work.”; and

(c) in subsection (3) by the deletion of the words “six months.” and the substitution of the words “500 hours of work.”.

3. These regulations come into force on May 4, 2002.

EXPLANATORY NOTES

The amendments change the regulations to be consistent with the current language on probationary hours of work within the Collective Agreement between the province and the Workers Compensation Board, IRAC and the PEI union of Public Sector Employees.

Pursuant to clause 5(1)(b) of the *Employment Standards Act* R.S.P.E.I. 1988, Cap. E-6.2 Council approved the following Minimum Wage Order made by the Employment Standards Board:

1. Section 1 of the *Employment Standards Act* Minimum Wage Order (EC139/96) is revoked and the following is substituted:

Minimum rate 1. The minimum rate of wages for all employees shall be:
 \$6.25 per hour effective 1 January 2003
 \$6.50 per hour effective 1 January 2004
 \$6.80 per hour effective 1 January 2005

2. This Order comes into force on January 1, 2003.**EXPLANATORY NOTE**

This adjustment in the minimum wage rate is based on an annual review by the Employment Standards Board, undertaken in accordance with subsection 5(2) of the Act.
