PART II REGULATIONS

HIGHWAY TRAFFIC ACT TRAFFIC SIGNS REGULATIONS **AMENDMENT**

Pursuant to sections 242 and 243 of the Highway Traffic Act R.S.P.E.I. 1988, Cap. H-5, the Minister of Transportation and Public Works made the following regulations:

- 1. Subsection 5(1) of the Highway Traffic Act Traffic Signs Regulations (Jan. 19/84) is amended by the deletion of the words "A maximum speed" and the substitution of the words "Subject to section 5.1, a maximum speed".
- 2. The regulations are amended by the addition of the following:
- **5.1** (1) "Variable speed sign" means an electronic sign that

"Variable speed

- (a) uses an illuminated screen to display the maximum speed limit sign" in kilometres per hour; and
- (b) is capable of being varied to indicate a maximum speed for a highway or part of a highway as any two-digit number ending in zero.
- (2) Where permitted by the Minister, a variable speed sign may be Use of variable used on a highway or any part of a highway.

speed sign

(3) Where use of a variable speed sign is permitted pursuant to Effect of variable subsection (2), the maximum speed on the highway or part of the speed sign highway shall be the number displayed on the variable speed sign.

(4) A variable speed sign shall be as depicted in Diagram 5.1 of Depiction Schedule A.

3. Schedule A of the regulations is amended by the addition of the following:

5.1 VARIABLE SPEED SIGN

4. These regulations come into force on May 18, 2002.

EXPLANATORY NOTES

The change will allow for use of variable speed signs on any highway throughout the province. Variable speed signs are currently in use on the Confederation Bridge.

SCHOOL ACT SCHOOL BOARDS REGULATIONS AMENDMENT

1. Clause 12(2)(b) of the *School Act* School Boards Regulations (EC225/96) is revoked and the following substituted:

- (b) publish in the daily and weekly newspapers of the province
 - (i) the names of all eligible candidates,
 - (ii) the names of their respective electoral zones, and
 - (iii) the location of the polling stations in each electoral zone.

2. These regulations come into force on May 7, 2002.

EXPLANATORY NOTES

This amendment changes the provision requiring the Chief Electoral Officer to publish in newspaper advertisements a full description of the electoral zones.
