ANIMAL HEALTH AND PROTECTION ACT
BEE HEALTH REGULATIONS
AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 18 June 2002.)

Pursuant to section 4 of the *Animal Health and Protection Act* R.S.P.E.I. 1988, Cap. A-11.1, Council made the following regulations:

1. Section 5 of the *Animal Health and Protection Act* Bee Health Regulations (EC271/01) is amended

(a) by the revocation of subsection (2) and the substitution of the following:

(2) No person may transport bees into the province unless the bees come from an area that is designated under subsection (3) as being free of Class A diseases. Transport from designated areas

(b) by the revocation of subsection (3) and the substitution of the following:

(3) The following are designated as areas that are free of Class A diseases: Designated areas

- (a) the province of Nova Scotia;
- (b) the state of Hawaii, U.S.A.;
- (c) the countries of Australia and New Zealand.

2. These regulations come into force on June 29, 2002.

EXPLANATORY NOTES

The amendments clarify that bees may be transported into the province only from designated areas and add the state of Hawaii to the list of areas that are designated as free of Class A diseases.

**LENDING AGENCY ACT
REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 18 June 2002.)

Pursuant to section 13 of the *Lending Agency Act* R.S.P.E.I. 1988, Cap. L-8.2, Council made the following regulations:

1. Section 10 of the *Lending Agency Act Regulations* (EC406/99) is amended

(a) by the deletion of the period at the end of clause (f) and the substitution of a semicolon; and

(b) by the addition of the following:

aerospace sector

- (g) “aerospace sector” includes any person that
- (i) carries on business or intends to carry on business in the province,
 - (ii) owns or will acquire assets of an aviation or aerospace-related business with loan proceeds received pursuant to the Act or the regulations, and
 - (iii) is actively engaged in or intends to work actively in an aviation or aerospace-related business.

2. These regulations come into force on June 29, 2002.**EXPLANATORY NOTES**

The amendment adds “aerospace sector” to the list of sectors of economic activity.

LICENSURE REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 18 June 2002.)

Pursuant to section 11 of the *Optometry Act* R.S.P.E.I. 1988, Cap. O-6, the following regulations were made by the Prince Edward Island College of Optometrists after consultation with the Association and with the approval of the Lieutenant Governor in Council:

1. Section 22 of the *Optometry Act* Licensure Regulations (EC473/95) is amended

(a) in clause (b) by the deletion of the words “\$250” and the substitution of the words “700”;

(b) in clause (c) by the deletion of the words “\$100” and the substitution of the words “\$275”;

(c) in clause (d) by the deletion of the words “\$200” and the substitution of the words “\$700”;

(d) in clause (g) by the deletion of the words “as the College determines appropriate, but not above fee for initial license” and the substitution of the words “same as for initial license fee but prorated according to duration of license”.

2. These regulations are deemed to have come into force on November 30, 2001.**EXPLANATORY NOTES**

The amendments change the fees for licenses and renewals to the amounts proposed by the College and approved by the Association.
