EC2002-328

SECURITIES ACT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 2 July 2002.)

Pursuant to section 27 of the *Securities Act* R.S.P.E.I. 1988, Cap. S-3, Council made the following regulations:

1. Subsection 2(3) of the *Securities Act* Regulations (EC165/89) is revoked and the following substituted:

- (3) Where the issuer is
 - (a) a bank to which the Bank Act (Canada) applies; or
 - (b) a company undertaking and transacting life insurance licensed under the *Insurance Act*,

the financial statements of the bank or insurance company are not required to comply with the following provisions if the financial statements are prepared in accordance with a statute incorporating, continuing or governing the bank or insurance company and any applicable generally accepted accounting principles:

- 1. Subsection (1).
- 2. Subsection 9.1(1) of Ontario Securities Commission Rule 41-501- General Prospectus Requirements.
- 3. Subsection 7.1(1) of National Instrument 44-101 Short Form Prospectus Distributions.
- 2. The heading before section 3 and sections 3 to 6 of the regulations are revoked.
- 3. Section 7 of the regulations is revoked.
- 4. Paragraphs 1, 2 and 4 to 7 of subsection 8(1) of the regulations are revoked.
- 5. The heading before section 9 and section 9 of the regulations are revoked.
- 6. Section 10 of the regulations is revoked and the following substituted:

Exception, banks and insurance companies

Form of prospectus

- **10.** Except where otherwise provided in the Act, these regulations or the rules made under the Act, a prospectus shall be prepared in accordance with such forms as the Director may approve.
- 7. Sections 11 to 19 of the regulations are revoked.
- 8. Section 20 of the regulations is revoked.
- 9. Subsection 21(1) of the regulations is amended by the deletion of the words "and every summary statement of a mutual fund".
- 10. Subsections 21(2) and (3) of the regulations are revoked and the following substituted:

Financial statements

(2) The financial statements described in subsection (1) may be omitted from the prospectus of the mutual fund if a copy of the financial statements that are otherwise required by subsection (1) is filed concurrently with the filing of the prospectus or if a copy of them has previously been filed under the Act.

Other statements

- (3) If, under subsection (2), a prospectus of a mutual fund does not contain the financial statements described in subsection (1), a prospectus that is sent or delivered to a purchaser of securities under section 8.16 of the Act shall be accompanied by
 - (a) a copy of the financial statements that are otherwise required by subsection (1); and
 - (b) if one or more financial statements for periods subsequent to those covered by the financial statements referred to in clause (a) have been filed under the Act, a copy of the financial statements most recently filed before the day on which the prospectus is sent or delivered to the purchaser.
- 11. Subsection 21(4) of the regulations is amended by the deletion of the portion before the statement and the substitution of the following:

Mandatory statement where financial statements omitted

- (4) If, under subsection (2), a prospectus of a mutual fund does not contain the financial statements described in subsection (1), the following statement shall be printed on the outside cover page of the prospectus:
- 12. Sections 22 to 27 of the regulations are revoked.
- 13. These regulations come into force on August 1, 2002.

EXPLANATORY NOTES

SECTION 1 amends the financial statement requirements for banks and insurance companies to include reference to instruments adopted by rule.

SECTIONS 2 to 5 revokes some unnecessary headings and sections which have been replaced by rules.

SECTION 6 amends the format requirement for prospectuses to remove references to prospectuses whose format is now governed by rules, and provides that all other prospectuses shall be prepared in accordance with such forms as the Director may approve.

SECTION 7 and 8 revoke sections which have been replaced by rules.

SECTIONS 9 to 11 amend the mutual fund financial statement requirements in accordance with the rules regulating mutual funds.

SECTION 12 revokes sections which have been replaced by rules.

SECTION 13 provides for the commencement of these amendments.

WORKERS COMPENSATION ACT GENERAL REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 2 July 2002.)

Pursuant to section 80 of the *Workers Compensation Act* R.S.P.E.I. 1988, Cap. W-7.1, Council approved the following regulations made by the Workers Compensation Board:

1. The Workers Compensation Act General Regulations (EC831/94) is amended by the addition of the following:

1.1 In the Act or these regulations,

Additional definitions

- (a.1) "CPP" means the Canada Pension Plan established by the CPP Canada Pension Plan Act (Canada);
- (c) "normal recovery time" means the estimate approved by the time Board of the normal time required for workers with a particular type of personal injury to return to work after the injury;

normal recovery

pain management program (d) "pain management program" means a program approved by the Board for the purpose of managing chronic pain.

2. Section 8 of the regulations is amended

(a) by renumbering the section as subsection (1);

(b) in subsection (1) as renumbered,

(i) by the deletion of the words "The following are the amounts prescribed for payments to be made under section 37 of the Act effective from January 1, 1995" and the substitution of the words "The following are the amounts prescribed for payments to be made under sections 37 and 38 of the Act",

(ii) by the revocation of subclause (b)(ii) and the substitution of the following:

(ii) subject to subsection (4), where the accident occurred after December 31, 1991, an amount equal to 70% of the wage loss benefits that would have been payable to the worker under the Act, less an amount equal to the percentage amount of CPP survivor benefits that are payable to the spouse, as determined under subsection (3);

(c) by the addition of the following:

Surviving spouse monthly payments calculations

- (2) For the purposes of subclause (1)(b)(ii), the wage loss benefits that would have been payable to a deceased worker shall be determined
 - (a) as if the wage loss benefits had already been paid for at least 38 weeks; and
 - (b) without the waiting period that would otherwise be required under subsection 40(1.2) of the Act.

(d) by the addition of the following:

Idem

- (3) For the purposes of subclause (1)(b)(ii), the percentage amount of CPP survivor benefits that shall be deducted is
 - (a) 100%, in respect of a monthly payment for the period before July 1, 2002; and
 - (b) 50%, in respect of a monthly payment for the period after June 30, 2002.

Payable until age 65

(4) The amount determined under subclause (1)(b)(ii) shall be payable until the spouse reaches age 65 or the worker would have reached age 65, whichever is later.

3. Section 9 of the regulations is amended

(a) by the deletion of the words ", in recognition of loss of opportunity,"; and

- (b) in clause (c),
 - (i) by the deletion of the word "latest", and
 - (ii) by the deletion of the words "a reference" and by the substitution of the words "as approved by the Board".

4. The regulations are amended by the addition of the following:

10. (1) The Board may approve the participation by a worker in a pain Board approval of management program if the worker is suffering from chronic pain.

pain management program

(2) Where the Board has approved participation in a pain management Payments program under subsection (1), the Board shall pay to or on behalf of the worker,

- (a) for each week that the worker participates in the pain management program, an amount equal to the amount that would be payable under the Act for the week if the worker were eligible for temporary wage loss benefits; and
- (b) such amount as the Board considers appropriate for the costs of the pain management program, including the registration cost for the program and the accommodation and travel costs of the worker.
- (3) No payment may be made by the Board to a worker under clause No double payment (2)(a)
 - (a) after the worker has received payments under that clause for a period of six weeks; or
 - (b) if the worker
 - (i) is eligible for temporary wage loss benefits under the Act, or
 - (ii) would receive an amount greater than the amount that the worker would otherwise be eligible to receive under the Act.

5. These regulations come into force on July 1, 2002.

EXPLANATORY NOTES

The amendments define terms used in the Act and these regulations. reduce the amount of CPP that must be included in calculations and provide for benefits to be paid to workers participating in a pain management program.
