  - (8) Restrictions imposed pursuant to Regulation 28.(7) may include:
  - (a) an audit of the firm's trust account or requiring that the firm carry out an audit at their expense with a report made to the Law Society,
  - (b) limiting the member's signing authority over trust money, and
  - (c) any other steps required to protect trust money.
