- (8) *Restrictions imposed pursuant to Regulation 28.(7) may include:*
- (a) *an audit of the firm's trust account or requiring that the firm carry out an audit at their expense with a report made to the Law Society,*
 - (b) *limiting the member's signing authority over trust money, and*
 - (c) *any other steps required to protect trust money.*
