HEALTH SERVICES PAYMENT ACT REGULATIONS **AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 6 August 2002.)

Pursuant to section 5 of the Health Services Payment Act R.S.P.E.I. 1988, Cap. H-2, Council made the following regulations:

1. Section 19 of the Health Services Payment Act Regulations (EC 453/96) is revoked and the following substituted:

19. (1) A claim for payment in respect of basic health services rendered Time for to an entitled person that contains the information required pursuant to submission of claim section 18 shall be submitted

- (a) if the claim is submitted by the entitled person, within six months of the date on which the service was rendered; and
- (b) if the claim is submitted by a participating service provider who rendered the service, within three months of the date the service was rendered.
- (2) Unless the Minister otherwise determines, no payment may be Claim out of time made in respect of a claim that is not submitted within the relevant time period set out in subsection (1).

(3) Except where an entitled person is charged for a basic health Payment to service and submits a claim in respect thereof pursuant to section 11 of participating service the Act or section 24 of these regulations, payment for the basic health service shall be made to the participating service provider in accordance with these regulations.

2. The regulations are amended by the addition of the following:

MISCELLANEOUS

39. (1) The Minister may disclose information obtained in the Information administration of the Act

disclosure

- (a) in connection with the administration of the Workers Compensation Act R.S.P.E.I. 1988, Cap. W-7.1; and
- (b) to surveyors authorized by the Canadian Council on Health Services for the purpose of carrying out an accreditation survey.

Electronic systems

(2) The Minister may authorize persons responsible for the implementation, support, maintenance and development of the claims processing system to have access to the electronic information maintained within the system.

Information regarding payment

- **40.** (1) Where an injured person has received a sum paid for basic health services that is required to be paid to the Minister pursuant to subsection 22(3) of the Act, the person shall also provide the Minister with the following information:
 - (a) copies of the pleadings of all parties;
 - (b) a copy of the memorandum of settlement or judgment, as applicable;
 - (c) the amount claimed as the cost of basic health services, if not specified in the pleadings;
 - (d) the amount payable to the Minister.

Legal fees

- (2) The payment of recovery fees pursuant to subsection 22(14) of the Act shall be as follows:
 - (a) 15% on the first \$5,000 or less that is recovered;
 - (b) 10% on the next \$10,000 that is recovered;
 - (c) 5% on the amount recovered in excess of \$15,000.
- 3. These regulations come into force on August 17, 2002.

EXPLANATORY NOTES

SECTION 1 requires that a claim for basic health services be submitted within six months by a patient and within three months by the provider of the basic health service. The penalty for missing the deadline may be non-payment of the claim. Payment is usually made to the service provider.

SECTION 2

- allows disclosure for the purposes of the Workers Compensation Act and accreditation surveys;
- authorizes access to electronic information by persons supporting electronic systems;
- specifies details required on payment of portions of settlements or judgments related to insured services;
- specifies recovery fees payable by the Minister.

SECTION 3 is the effective date.

HOSPITAL AND DIAGNOSTIC SERVICES INSURANCE ACT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 6 August 2002.)

Pursuant to section 11 of the *Hospital and Diagnostic Services Insurance* Act R.S.P.E.I. 1988, Cap. H-8, Council made the following regulations:

- 1. Clause 1(0) of the Hospital and Diagnostic Services Insurance Act Regulations (EC539/63) is amended by the revocation of subclause (v) and the substitution of the following:
 - (v) when used for the provision of diagnosis and treatment, any drugs, biologicals and related preparations that are prescribed by an attending physician in accordance with accepted practice and sound teaching and are administered in a hospital, but not including any medications and medical and surgical supplies which are taken home by the out-patient;

2. The regulations are amended by the addition of the following:

MISCELLANEOUS

27. (1) The Minister may disclose information obtained in the Information disclosure administration of the Act

- (a) in connection with the administration of the Workers Compensation Act R.S.P.E.I. 1988, Cap. W-7.1; and
- (b) to surveyors authorized by the Canadian Council on Health Services for the purpose of carrying out an accreditation survey.
- (2) The Minister may authorize persons responsible for the Electronic systems implementation, support, maintenance and development of the claims processing system to have access to the electronic information maintained within the system.

28. (1) Where an injured person has received a sum paid for insured Information services that is required to be paid to the Minister pursuant to subsection regarding payment 14(3) of the Act, the person shall also provide the Minister with the following information:

- (a) copies of the pleadings of all parties;
- (b) a copy of the memorandum of settlement or judgment, as applicable;
- (c) the amount claimed as the cost of insured services, if not specified in the pleadings;
- (d) the amount payable to the Minister.

Legal fees

- (2) The payment of recovery fees pursuant to subsection 14(14) of the Act shall be as follows:
 - (a) 15% on the first \$5,000 or less that is recovered;
 - (b) 10% on the next \$10,000 that is recovered;
 - (c) 5% on the amount recovered in excess of \$15,000.
- 3. These regulations come into force on August 17, 2002.

EXPLANATORY NOTES

SECTION 1 clarifies that those medical/surgical supplies and medications used at a hospital are insured services, but not those taken home by a patient.

SECTION 2

- clarifies coverage of outpatient services;
- allows disclosure for the purposes of the *Workers Compensation Act* and accreditation surveys;
- authorizes access to electronic information by persons supporting electronic systems;
- specifies details required on payment of portions of settlements or judgments related to insured services;
- specifies recovery fees payable by the Minister.
