LOTTERIES COMMISSION ACT VIDEO LOTTERY SCHEME REGULATION **AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 17 December 2002.)

Pursuant to section 15 of the Lotteries Commission Act R.S.P.E.I. 1988, Cap. L-17, Council made the following regulations:

- 1. Section 1 of the Video Lottery Scheme Regulation (EC361/91) is amended
 - (a) by the revocation of clause 1(1)(i); and
 - (b) in clause 1(1)(k), by the deletion of the words "by the insertion of coins".
- 2. The heading before section 8 and sections 8 to 13 of the regulations are revoked.
- 3. Section 14 of the regulations is revoked and the following substituted:
- 14. The Corporation may acquire video lottery devices and may provide Video lottery them to siteholders in accordance with these regulations and in such manner as the Corporation considers appropriate.

- 4. Clause 15(b) of the regulations is amended by the deletion of the words "an owner" and the substitution of the words "the Corporation, subject to the terms and conditions established by the Corporation,".
- 5. Section 17 of the regulations is amended
 - (a) in clause (a), by the deletion of the semicolon and the substitution of the words "; and";
 - (b) by the revocation of clauses (b) and (d); and
 - (c) in clause (c), by the deletion of the semicolon and the substitution of a period.

- 6. Section 27 of the regulations is amended by the deletion of the words "or owner" wherever they occur.
- 7. Section 29 of the regulations is amended by the addition of the words "conditions contained in an agreement between a siteholder and the Corporation or" after the words "including but not limited to".
- 8. Section 34 of the regulations is amended by the deletion of the words "an owner or siteholder" and the substitution of the words "a siteholder".
- 9. These regulations come into force on the expiry of December 31, 2002.

EXPLANATORY NOTES

The amendments remove owners who presently own and maintain video lottery devices from the video lottery scheme.
