Under the Prince Edward Island Egg Commodity Marketing Plan and the *Natural Products Marketing Act*, R.S.P.E.I.1988, Cap. N-3, the Egg Producers of Prince Edward Island makes the following Order:

AMENDMENT TO BOARD ORDER ECMB88-2

Application

1. This Order amends the levy rate contained in Subsection 6(a) of Board Order 88-2.

Levy rate amended

- 2. Subsection 6(a) of Board Order 88-2 is hereby deleted and the following substituted therefor:
- 6.(a) A marketing charge on ungraded eggs shall be levied annually by the Board on the producers, subject to change by the Board, and the charge shall be based on a producer's allocated quota at the rate of thirty two point one cents (\$0.321) per dozen eggs and it is established that the minimum number of eggs per bird shall be, in the case of leghorns and dual purpose birds, twenty four point four (24.4) dozen eggs per annum except that during a year that has fifty-three (53) weeks the minimum number of eggs per bird shall be twenty-four point nine (24.9) dozen eggs per annum.
- 3. This Order shall come into force on the 29th day of December, 2002.

Under the Prince Edward Island Egg Commodity Marketing Plan and the *Natural Products Marketing Act*, R.S.P.E.I.1988, Cap. N-3, the Egg Producers of Prince Edward Island makes the following Order:

STABILIZATION PAYMENTS AND SOURCING OF EGGS

Application

1. This Order is established to:

[a] make the provincial Industrial Product Program more transparent and market responsive, and

[b] to establish a policy for sourcing eggs and allocating stabilization funds to grading stations, and

[c] to ensure that eggs for the Prince Edward Island table market, produced by Prince Edward Island egg producers, are of the highest quality available.

Sourcing

of Eggs

2. Sourcing of eggs outside Prince Edward Island should not occur unless eggs of suitable size and quality are not available in Prince Edward Island.

Idem

Grading stations may, and are encouraged to, source their nest run and graded egg requirements direct from other Prince Edward Island grading stations wherever possible.

Idem

4. Grading stations must source graded eggs direct from other grading stations. The Board will not source graded eggs for grading stations.

Nest run eggs

5. This Order shall only apply to grading stations that declare nest run eggs, however, by mutual agreement the policy may be changed by the Board at a later date to include grading stations that declare only graded eggs.

Eligibility

6. To be eligible for the declaration of industrial product eggs, a grading station must hold a current federal license issued by Canadian Food Inspection Agency and be capable of grading all their incoming eggs in a timely fashion.

Orders for eggs

7. Grading stations that wish to order nest run eggs from the Board must do so on the approved form by 4:00 pm on Friday of the week before the eggs are required or on the previous business day where Friday is a holiday. Late orders will not be accepted by the Board.

Idem

8. To be accepted as a valid order, the ordering grading station must not have declared nest run eggs at the ordered class in the previous week.

Nest run weights

9. The weight of nest run eggs per box of 15 dozen eggs, used for declaration purposes, are:

14-16, 16-17, 17-18, 18-19, 19-20, 20-21, 21-22, 22-23, 23-24, 24-25, 25+ Lbs.

Idem

10. Nest run classes for the purposes of this Order shall be:

Class 1 - <19 Lbs - Not eligible for grading

Class 2 - 19-22 Lbs - Eligible for grading into Canada Grade A Medium Class 3 - >22 Lbs - Eligible for grading into Canada Grade A Large

Classes ordered

11. A grading station ordering nest run eggs shall indicate the nest run class required. Classes are described above. Orders must be placed in normal pallet lots of either 60 or 48 boxes per pallet.

Declarations

12. Grading stations shall declare their industrial product eggs to the Board no later than 12:00 noon on Monday of each week or on the next business day where Monday is a holiday. Declarations received after 12:00 noon will be rejected.

Summary of available eggs

13. By 2:00 pm on each Monday afternoon, the Board will provide grading stations with a summary of nest run and graded eggs declared by each grading station.

Idem

- 14. Provided nest run eggs in the ordered class are available from another grading station, the Board will direct the grading station ordering the nest run eggs to obtain its order from the most practical source and the Board will reduce the declaration of the source by the appropriate amount. The Board will take into account the following elements:
- [a] Where one grading station has sufficient nest run eggs to fill the order, and the other grading station does not have sufficient nest run eggs to fill the order, the Board will direct the grading station ordering the eggs to source the eggs from the grading station that has sufficient nest run eggs available.
- [b] Where one grading station does not have sufficient nest run eggs to fill the order, and the other grading station does not have sufficient nest run eggs to fill the order, but together the two grading stations have enough nest run eggs to fill the order, the Board will direct the grading station ordering the eggs to source the nest run eggs from the grading station with the most nest run eggs available first and to source the balance of the nest run eggs from the other grading station.
- [c] Where the two grading stations together do not have enough nest run eggs to fill the order, the Board will direct the grading station ordering the nest run eggs to source all available nest run eggs at both locations.

[d] Nest run eggs purchased by a grading station under this Order must be picked up by the end of normal business hours on Wednesday unless the purchaser and seller agree on another time.

Cost of purchased eggs

15. The grading station purchasing eggs under this Order shall be responsible for the cost of the eggs purchased and for all pickup and delivery costs and for the return of supplies to the selling grading station where the selling grading station provides the supplies or for pallets, fillers and dividers where the purchasing grading station provides the supplies.

Stabilization Payments

16. A grading station ordering nest run eggs from the Board will not receive stabilization payments on nest run eggs declared at the ordered class in the two weeks immediately following the week in which the order was filled up to the amount of nest run eggs sourced from other grading stations.

Idem

17. Where a grading station declares nest run eggs in section 16 above, the stabilization payments will be returned by the Board to the grading station(s) declaring nest run eggs on the same basis the stabilization payments were reduced when the order was filled.

Idem

- 18. Except as provided above, the following stabilization payments will be made by the Board:
- [a] Stabilization payments will be made to grading stations on graded eggs at the rates established by the Board from time to time.
- [b] Where no orders for nest run eggs are received by the Board, normal stabilization payments will be made to all grading stations declaring nest run eggs at the rate established by the Board.
- [c] Where the Board directs a grading station or grading stations to supply nest run eggs to another grading station, the Board will reduce the nest run stabilization payments to the grading stations supplying nest run eggs on a pro-rata basis.

Example of a Reduced Nest Run Stabilization Payment
Grading Station "A" orders and receives 200 Boxes of Class 3 Eggs
Grading Station "B" Declares 300 Boxes of Class 3 Eggs
Grading Station "C" Declares 200 Boxes of Class 3 Eggs
Stabilization to Grading Station "B" is Reduced by 120 Boxes (300/500 X 200)
Stabilization to Grading Station "C" is Reduced by 80 Boxes (200/500 X 200)

Price of eggs

19. The price at which a grading station shall sell another grading station nest run eggs purchased and sold under these guidelines shall be the lower of the cost of production or the producer price plus a handling fee of \$0.03 per dozen.

Payments by the Board

20. Where a shortage of eggs occurs at a grading station and the eggs are ordered and sourced through the Board from another grading station, the Board will pay the purchasing grading station \$0.03 per dozen for freight and additional handling which will be charged to the provincial stabilization account.

Maximum freight payments

21. The maximum amount of stabilization payments to be paid by the Board under section 21 shall be \$5,000 per annum up to a maximum of \$2,500 per grading station on nest run eggs only.

Effective date

22. This Order shall come into force on the 29th day of December, 2002.
