### EMPLOYMENT STANDARDS ACT EMPLOYMENT STANDARDS RECIPROCITY ORDER AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 15 April 2003.)

Pursuant to section 42 of the Employment Standards Act R.S.P.E.I. 1988, Cap. E-6.2, Council made the following order:

Employment Standards Act Employment Standards 1. The Reciprocity Order (EC810/95) is amended by the addition of the following:

6. (1) The Province of Newfoundland and Labrador is declared to be a Reciprocating reciprocating province for the purpose of the enforcement of orders made province under the Employment Standards Act of that province.

Newfoundland and Labrador

(2) The Director of Employment Standards of the Province of Authority Newfoundland and Labrador is designated as the authority within that province for the purposes of clause 42(1)(b) of the *Employment* Standards Act.

2. This Order comes into force on April 26, 2003.

### **EXPLANATORY NOTES**

The order adds Newfoundland and Labrador as a reciprocating province for the purpose of enforcement orders made under the Employment Standards Act of that province.
