1. Section 3 of the Environmental Protection Act Petroleum Storage Tanks Regulations (EC322/01) is amended by the addition of the following after subsection (2):

(3) Every person who installs a small capacity storage tank on or after Identification label the date this subsection comes into effect shall affix a Form 3A identification label permanently to the vent pipe as part of the installation process.
