GASOLINE TAX ACT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 19 August 2003.)

Pursuant to section 9 of the *Gasoline Tax Act* R.S.P.E.I. 1988, Cap. G-3, Council made the following regulations:

- 1. Subsection 15(3) of the *Gasoline Tax Act* Regulations (EC283/72) is amended
 - (a) by the deletion of the words "; and" after clause (n);
 - (b) by the deletion of the period after clause (o) and the substitution of a semicolon; and
 - (c) by the addition of the following after clause (o):
 - (p) for furnishing power to motorized equipment for use in agricultural and aquacultural operations owned and operated by AVC Incorporated; and
 - (q) for furnishing power for equipment used by custom agricultural contractors providing custom agricultural services to farmers and for no other commercial purpose.
- 2. These regulations come into force on August 30, 2003.

EXPLANATORY NOTES

SECTION 1 extends the uses that may be made of marked gasoline.

SECTION 2 provides for the commencement of these regulations.

REVENUE ADMINISTRATION ACT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 19 August 2003.)

Pursuant to section 28 of the *Revenue Administration Act*, R.S.P.E.I. 1988, Cap. R-13.2, Council made the following regulations:

1. The *Revenue Administration Act* Regulations (EC390/91) are amended by the addition of the following after section 15.1:

Assessments, back taxes

- **15.2** In making an assessment pursuant to the *Revenue Administration Act*, the Commissioner shall not consider a period prior to the sixty months immediately preceding the month in which the assessment is made, except
 - (a) with respect to a sale or purchase of goods recorded in the books of account of the taxpayer during the sixty month period immediately preceding the month in which the assessment is made and the delivery of these goods took place prior to that period; or
 - (b) where there is a reasonable appearance of wilful default or fraud to the Commissioner.
- 2. These regulations come into force on August 30, 2003.

EXPLANATORY NOTES

SECTION 1 provides for the time period for making assessment under the Act.

SECTION 2 provides for the commencement of these regulations.
