(Approved by His Honour the Lieutenant Governor in Council dated 28 October 2003.)

Pursuant to section 77 of the *Freedom of Information and Protection of Privacy Act* R.S.P.E.I. 1988, Cap. F-15.01 Council made the following regulations:

**EC2003-612****PLANNING ACT  
SUBDIVISION AND DEVELOPMENT REGULATIONS  
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 28 October 2003.)

Pursuant to sections 8 and 8.1 of the *Planning Act* R.S.P.E.I. 1988, Cap. P-8, Council made the following regulations:

**1. The *Planning Act* Subdivision and Development Regulations (EC693/00) is amended by the addition of the following after subsection 6(2):**

Exemption

(3) Subsection (1) does not apply in respect of any development of or on the following:

- (a) the building and property located at 5 and 7 Ashwood Avenue, Slemon Park, being approximately 0.83 acres, and bounded by Ashwood Avenue, Fifth Street and Cherrywood Avenue;
- (b) the buildings and property located at 66 Argus Avenue, Slemon Park, being approximately 6.01 acres, and bounded by Argus Avenue, Fifth Street and Redwood Avenue.

**2. Section 17 of the regulations is amended by the addition of the following after subsection (3):**

Exemption

(4) Subsections (1) and (2) do not apply in respect of any development of or on the following:

- (a) the building and property located at 5 and 7 Ashwood Avenue, Slemon Park, being approximately 0.83 acres, and bounded by Ashwood Avenue, Fifth Street and Cherrywood Avenue;
- (b) the buildings and property located at 66 Argus Avenue, Slemon Park, being approximately 6.01 acres, and bounded by Argus Avenue, Fifth Street and Redwood Avenue.

**3. These regulations come into force on October 28, 2003.**

**EXPLANATORY NOTES**

The amendments exempt the specified site areas within Slemon Park from the restriction on development of a lot, parcel or subdivision served by a private road and from the requirement for a subdivision to have public roads with a minimum width of 66 feet.
