### HIGHWAY TRAFFIC ACT FARM TRUCK REGISTRATION REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 30 March 2004.)

Pursuant to section 31 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

- 1. Section 1 of the *Highway Traffic Act* Farm Truck Registration Regulations (EC356/74) is amended
  - (a) in clause (a), by the deletion of the word "fifty" wherever it occurs and the substitution of the words "twenty-five"; and

- (b) in clause (c), by the deletion of the word "1500" and the substitution of the word "4,500".
- 2. Subsection 7(2) of the regulations is amended by the deletion of the words "and is liable on summary conviction to a fine not exceeding one hundred dollars but not being less than ten dollars and in default of payment thereof to a maximum of thirty days imprisonment" and the substitution of the words "and is liable on summary conviction to a fine of not less than \$500 and not more than \$1,000 and in default of payment is liable to imprisonment for a term of not more than 30 days, or to both".
- 3. These regulations come into force on April 10, 2004.

#### **EXPLANATORY NOTES**

**SECTION 1** amends the required percentage of working time that a *bona fide* farmer has to spend on his or her farm and amends the minimum weight rating of a farm truck.

**SECTION 2** updates the penalty section.

**SECTION 3** provides for the commencement of these regulations.

#### EC2004-205

### REAL PROPERTY TAX ACT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 30 March 2004.)

Pursuant to section 43 of the *Real Property Tax Act* R.S.P.E.I. 1988, Cap. R-5, Council made the following regulations:

- 1. The *Real Property Tax Act* Regulations (EC512/72) are amended by the addition of the following after section 24:
- **24.1** Where a person is eligible under section 5.1 of the Act to receive a tax credit, tax credit in respect of a residential property for a calendar year, the amount of the tax credit is the amount determined by the formula

 $[A - B] \times [(C/D) \times ((1.50 - E)/100)]$ 

where

- A is the assessed value of the residential property for the calendar year for which the credit is calculated;
- B is the sum of
  - (a) the value obtained by adjusting the assessed value of the residential property as of December 31, 2002 with the annual percentage increase in the All-Items Consumer Price Index for Prince Edward Island for the calendar year 2002 and for every subsequent calendar year until the calendar year immediately preceding the calendar year for which the credit is calculated; and (b) the value obtained by adjusting the assessed value of any improvements made to the residential property after December 31, 2002 with the percentage increase in the All-Items Consumer Price Index for the Prince Edward Island for every calendar year after the calendar year in which the improvement was made until the calendar year immediately preceding the calendar year for which the credit is calculated;
- C is the number of days during the calendar year for which the credit is calculated that the residential property was owned by the person;
- D is the number of days in the calendar year for which the credit is calculated: and
- E is the amount of the tax credit per \$100 of assessment that the person is eligible to receive under section 5 in respect of the residential property.
- 2. These regulations are deemed to have come into force on January 1, 2003.

#### **EXPLANATORY NOTES**

These regulations provide for the determination of the amount of the tax credit that the owner of a residential property may be eligible to receive under section 5.1 of the Act. This tax credit will provide a Consumer Price Index based limit on the tax increases that eligible residential property owners will experience due to increases in assessed property values.

#### **EXPLANATORY NOTES**

This amendment will reclassify 0.2 km of the unpaved portion of the Old North Shore Road in the settlement of Goose River as a seasonal highway, enabling the Department of Transportation and Public Works to provide seasonal maintenance.
