Levy	3. (1) The Board establishes a levy of \$1.83 per market hog, sow, boar or stag marketed This levy includes\$0.85 for general administration of the Board, \$0.05 for product promotion, \$0.15 for APHIN, \$0.08 for grading, \$0.60 for Industry Development, and \$0.10 for defense of trade actions.
	(2) The levy shall be deducted by the processor; and the processor shall remit the levy to the Board within seven days of the deduction.
Remittance	4. (1) Every processor, within seven days of each calendar week, shall:
	(a) render to the Board a true and correct statement of all market hogs, sows, boars and stags slaughtered in the previous calendar week; and
	(b) remit to the Board the levy outlined in section 3 above.
	(2) Notwithstanding subsection (1), a processor, with the approval of the Board, within seven days of each month, shall:
	(a) render to the Board a true and correct statement of all market hogs, sows, boars and stags slaughtered in the previous month; and
	(b) remit to the Board the levy outlined in section 3.

# ENVIRONMENTAL PROTECTION ACT AIR QUALITY REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 27 July 2004.)

Pursuant to subsection 25(1) of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, Council made the following regulations:

**1.** Section **4.1** of the *Environmental Protection Act* Air Quality Regulations (EC377/92) is amended

(a) by the revocation of clause (1)(c) and the substitution of the following:

(c) in the amount as set out in Schedule D; and

(b) by the revocation of subsection (2) and the substitution of the following:

(2) The application fee for a permit or a renewal of a permit shall be in Fees for permit the amount as set out in Schedule D.

2. The regulations are amended by the addition of Schedule D as set out in the Schedule to these regulations.

3. These regulations come into force on August 7, 2004.
