PLANNING ACT

SUBDIVISON AND DEVELOPMENT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 17 August 2004)

Pursuant to clause 8(1)(i) of the Planning Act R.S.P.E.I. 1988 Cap. P-8, Council made the following regulations:

1. Section 65 of the Planning Act Subdivision and Development Regulations (EC693/00) is amended

(a) by the deletion of the period at the end of subclause (c)(i) and the substitution of a semicolon; and

(b) by the addition of the following after subclause (c)(i):

(ii) a portion of the road known as the Hackeney Road or the John Joe Road in the settlement of Mill River, commencing at a point 0.12 miles (0.2 km) from the intersection of Route 136 to the intersection of Route 142, a distance of approximately 1.42 miles (2.3 km).

2. The regulations are amended by the addition of the following after section 65:

65.1 Notwithstanding clause 1(s.2), "scenic heritage road" for the "scenic heritage purposes of subclause 65(c)(ii) means the verge, ditch and land within road", defined the road boundaries of the Hackeney Road.

3. These regulations come into force on August 28, 2004
