- 6.(a) A marketing charge on ungraded eggs shall be levied annually by the Board on the producers, subject to change by the Board, and the charge shall be based on a producer's allocated quota at the rate of thirty one point zero cents (\$0.310) per dozen eggs and it is established that the minimum number of eggs per bird shall be, in the case of leghorns and dual purpose birds, twenty four point four (24.4) dozen eggs per annum except that during a year that has fifty-three (53) weeks the minimum number of eggs per bird shall be twenty-four point nine (24.9) dozen eggs per annum.
- 3. This Order shall come into force on the 26th day of December, 2004.

EMERGENCY 911 ACT REGULATIONS **AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 21 December 2004.)

Pursuant to section 10 of the Emergency 911 Act R.S.P.E.I. 1988, Cap. E-5.1, Council made the following regulations:

1. Section 1 of the *Emergency 911 Act* Regulations (EC155/00) is amended

(a) by the addition of the following after clause (a):

- (a.1) "local subscriber" means a person who subscribes to the local subscriber services of a telecommunications carrier for a telephone service activated within the province;
- (a.2) "municipality which is responsible for civic addressing" means municipality any one of the following municipalities:
 - (i) Alberton,
 - (ii)) Borden-Carleton,
 - (iii) Brackley,
 - (iv) Charlottetown,
 - (v) Cornwall,
 - (vi) Georgetown,
 - (vii) Kensington,
 - (viii) Kinkora,
 - (ix) Miscouche,
 - (x) Montague,
 - (xi) O'Leary,
 - (xii) Souris,
 - (xiii) Stratford,
 - (xiv) Summerside,
 - (xv) Tignish,
 - (xvi) Victoria,
 - (xvii) Wellington;
- (b) by the deletion of the period after clause (b) and the substitution of a semicolon; and

(c) by the addition of the following after clause (b):

private roadway

- (c) "private roadway sign installation" means a private roadway sign installation consisting of
 - (i) a support post,
 - (ii) an anchor, if any,
 - (iii) a sign panel, and
 - (iv) sign panel fastening hardware.

2. Subsection 3(6) of the regulations is amended

- (a) in clause (a), by the deletion of the words "; and" and the substitution of a semicolon;
- (b) in clause (b), by the deletion of the period and the substitution of the words "; and"; and
- (c) by the addition of the following after clause (b):
- (c) be accompanied by
 - (i) in the case of a private roadway that is located in a municipality which is responsible for civic addressing, the municipal fee for each private roadway sign installation required by that municipality, or
 - (ii) in the case of a private roadway that is not located in a municipality which is responsible for civic addressing, the fee established under subsection 6(2).

3. Section 6 of the regulations is amended

- (a) by renumbering it as subsection 6(1); and
- (b) by the addition of the following:

Sign installation fee

(2) A property owner who creates a new private roadway in a subdivision that is located outside a municipality which is responsible for civic addressing shall pay a fee of \$150 to the Provincial Treasurer for each private roadway sign installation required by the PEI 911 administration.

Missing, damaged sign

- (3) Where a private roadway sign is missing or damaged to the extent that the sign is, in the opinion of the Minister, illegible by the travelling public, the PEI 911 administration shall replace the private roadway sign installation or the part of the sign installation that is missing or damaged.
- 4. The regulations are amended by the addition of the following after section 9:

911 service fee for telephone services

- **10.** (1) Subject to subsection (2), every local subscriber shall pay a 911 service fee of \$0.50 per month to the Provincial Treasurer for each of the following active telephone services:
 - (a) a single-line residential service;

- (b) a single-line business service;
- (c) a multi-line outgoing service;
- (d) each separately numbered Centrex service;
- (e) a wireless service.
- (2) The province may enter into agreements with telecommunications Agreements with carriers

telecommunications carriers

- (a) to collect the fee required by subsection (1) from local subscribers; and
- (b) to submit the fees collected under clause (a) to the Provincial Treasurer.

5. These regulations come into force on January 1, 2005

EXPLANATORY NOTES

The amendments add definitions, provide for fees for private roadway sign installations, a mechanism for replacing missing, illegible or damaged private roadway signs and establish a 911 service fee and method of payment of that fee.
