ORDER: DFPEI 2005-01 EFFECTIVE: February 1, 2005

Under the Dairy Farmers of Prince Edward Island Regulations and under the *Natural Products Marketing Act*, R.S.P.E.I.1988, Cap. N–3, Dairy Farmers of Prince Edward Island makes the following Order:

PRICE DETERMINATION ORDER

Application

1. This Order provides for the establishment of prices for each kilogram of butterfat, protein and other solids contained in milk used in the classes described in the Board's Classification of Milk Order.

Definitions

2. The words herein shall have the meanings as found in the Prince Edward Island Natural Products Marketing Act and the Dairy Farmers of Prince Edward Island Regulations unless differentiated herein and as hereinafter defined:

(a) "CMSMC" shall mean the Canadian Milk Supply Management Committee.
