#### **GREETING**

#### A PROCLAMATION

WHEREAS in and by section 6 of Chapter 5 of the Acts passed by the Legislature of Prince Edward Island in the 2nd Session thereof held in the year 2004 and in the fifty-third year of Our Reign intituled "An Act to Amend the Highway Traffic Act" it is enacted as follows:

"This Act comes into force on a date that may be fixed by proclamation of the Lieutenant Governor in Council.",

AND WHEREAS it is deemed expedient that the said Act, Stats. P.E.I. 2004, 2nd Session, c. 5 should come into force on the 5th day of February, 2005,

NOW KNOW YE that We, by and with the advice and consent of our Executive Council for Prince Edward Island, do by this Our Proclamation ORDER AND DECLARE that the said Act being "An Act to Amend the Highway Traffic Act" passed in the fifty-third year of Our Reign shall come into force on the 5th day of February, two thousand and five of which all persons concerned are to take notice and govern themselves accordingly.

### EPPEI 05-01 EGG PRODUCERS OF PRINCE EDWARD ISLAND

Under the Prince Edward Island Egg Commodity Marketing Regulations and the *Natural Products Marketing Act*, R.S.P.E.I.1988, Cap. N–3, the Egg Producers of Prince Edward Island makes the following Order:

#### PRICE DETERMINATION ORDER - AMENDMENT

#### Application

1. This Order amends the prices contained in Section 4 of Board Order 86-7.

#### Prices amended

- 2. Section 4 of Board Order 86-7 is hereby amended by the deletion of clauses (a) (b) and (d) and the substitution therefore of the following:
- (a) minimum Canada Grade A Producer Price by the dozen:

Ex Large \$1.50 Large \$1.50 Medium \$1.43 Small \$1.00

(b) suggested minimum Canada Grade A Wholesale Carton Price:
