ROADS ACT
HIGHWAY ACCESS REGULATIONS
AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 14 June 2005.)

Pursuant to section 29 of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15 Council made the following regulations:

1. Schedule A-1, Arterial Highways, of the *Roads Act Highway Access Regulations (EC580/95)* is amended by the revocation of subsection 1(7) and the substitution of the following:

(7) Route 150, from the intersection of Route 2 in the settlement of Elmsdale to the eastern boundary of property no. 32003 in the Community of Union.

2. Schedule B, Collector Highways, of the regulations is amended by the addition of the following:

(23) Route 150, commencing at the eastern boundary of property no. 32003 in the Community of Union to the intersection with Route 12 in the Town of Alberton.

3. These regulations come into force June 14, 2005.

EXPLANATORY NOTES

This amendment will reclassify 650 meters of Route 150 from an arterial highway to a collector highway, enabling the creation of new parcels of land along the newly designated collector highway.
