#### QUOTA LEASING ORDER

#### Application

 This order establishes a system for leasing quota between individual quota holders, assigned quota by the Dairy Farmers of Prince Edward Island under Prince Edward Island Milk Marketing Board Order MMB 01-02, dated 1 August 2001, and amendments thereto.

#### Definitions

- 2(1) In this order
  - (a) "quota lease" means an agreement granting the temporary assignment of milk quota from one registered quota holder (in this order registered quota holders are also referred to as producers) to another for a fee, which lease agreement established pursuant to this order is differentiated from leases made under the *Catastrophe Clause Quota Leasing Policy* established pursuant to MMB Order 01-02 dated 1 August 2001;
  - (b) "lessee" means a producer who has gained temporary use of a quantity of quota from another producer by way of a quota lease;
  - (c) "lessor" means a producer who has granted temporary use of a quantity of quota to another producer by way of a quota lease;
  - (d) "lease-in" means quota leased by a producer from other producers;
  - (e) "lease-out" means quota leased by a producer to other producers;
  - (f) "producer" means a producer of milk;
  - (g) "quota" means a producer's share of the market for milk products as determined by the Board and assigned to a producer by the Board;
  - (h) "quota leasing exchange" means an exchange established controlled and operated by the Board for the leasing of quota by producers on conditions established by the Board.
- (2) The words herein shall have the meanings as found in the Natural Products Marketing Act, the Dairy Farmers of Prince Edward Island Regulations under the Act, and prior orders of the Board applied to this Order with necessary modifications.

#### Ouota Lease

A quota lease shall be entered into between producers under the conditions established by this order.

### Lease Quantities and Limits

4. Quota may be leased in quantities expressed in kilograms of butterfat per day rounded to one decimal. The quantity of quota an individual producer may lease at any one time shall be limited to an amount specified from time to time by a Board Order. The specified maximum a producer may lease-in or lease-out effective 1 July 2005 shall be equal to not more than twenty-five percent (25%) of his quota holding in the month of the lease.

#### Term of Lease

Quota leases shall be for a period of one month only and shall expire at the end of each calendar month.

#### Quota Leasing

Exchange

The Board shall operate a quota leasing exchange for facilitation of quota leasing between producers.

#### Producer to Producer

Leases

A producer is permitted to enter into a quota lease directly with another producer, without participation in the quota leasing exchange.

#### Registration Fee

8. A registration fee of \$20.00 shall be paid to the Board at the time of all producer-to-producer leases for the purpose of administering the leasing of quota.

### Registration of Leases

9. All producer-to-producer leases shall be registered with the Board using a Quota Leasing Agreement Form. Lease agreements, together with required payments and registration fees, must be delivered to the Board office by 4 PM on the twenty-second day of the month preceding the month for which the quota is being leased. Where the twenty-second of a month falls on a weekend or a statutory holiday, the board shall accept producer-to-producer lease agreements on the next business day.

## Payment for Leases

10. All lessee payments for quota leases, regardless if the lease was under the quota leasing exchange or by a producer-to-producer lease agreement, shall be payable to Dairy Farmers of Prince Edward Island and payments shall be disbursed to lessors by the Board.

### Default of Payment

11. In the event of default of payment for a quota lease, the Board shall require the lessee to remit guaranteed payment, by bank draft or comparable payment instrument, within 2 business days of notice to a lessee that their payment has been dishonoured. The guaranteed payment remitted shall be sufficient to pay the cost of the lease and any related service charges levied by third parties.

#### Right of Offset

12. In the event of default of payment for a quota lease for which a producer is unable to provide guaranteed payment within 2 business days, as outlined in section 10, Dairy Farmers of Prince Edward Island shall retain to the right to offset the indebtedness created by the default of payment against future revenues for milk

sales, and shall withhold the required funds from future milk sales payments to the lessee for settlement of the account.

## Assignment to Lenders

13. A lessee may not assign leased quota to lenders. A lessor's obligation created by an assignment of quota to a lender is not relieved because any portion of that quota has been temporarily leased to another producer.

#### QUOTA LEASING EXCHANGE ORDER

Application

1. This Order provides for the establishment, control and operation by Dairy Farmers of Prince Edward Island of a quota leasing exchange to be operated for milk producers.

2(1) In this order

Definitions

- (a) "quota lease" means an agreement granting the temporary assignment of milk quota from one registered quota holder (in this order registered quota holders are also referred to as producers) to another for a fee. A quota lease as referred to in this order is a lease as established in DFPEI Order 2005-05 and is differentiated from leases made under the *Catastrophe Clause Quota Leasing Policy* created in MMB Order 01-02 dated 1 August 2001.
- (b) "lessee" means a producer who has gained temporary use of a quantity of quota from another producer by way of a quota lease;
- (c) "lessor" means a producer who has granted temporary use of a quantity of quota to another producer by way of a quota lease;
- (d) "cleared" means the process by which the Board shall conduct the temporary leasing of quota between producers who participate in the exchange;
- (e) "daily quota" means an amount of kilograms of butterfat that may be produced in one day, expressed to one decimal point;
- (f) "lease month" means the calendar month in which a producer's quota shall be adjusted by the amount of quota leased to or from other producers;
- (g) "lease clearing price" means the price at which the amount of quota offered for lease from producers on an exchange equals, or comes closest to, the amount of quota bid for leasing to producers, except that where the volume is the same for more than one price, the lowest price shall be used;
- (h) "lease-in" means quota leased by a producer from other producers;
- (i) "lease-out" means quota leased by a producer to other producers.
- (2) The words herein shall have the meanings as found in the *Natural Products Marketing Act*, the Dairy Farmers of Prince Edward Island Regulations under the Act, and prior orders of the Board applied to this Order with necessary modifications.

Exchange established

3. The Board hereby establishes and will operate a quota leasing exchange for the lease of daily quota held by producers.

#### Eligible producers

4. Only producers registered by the Board shall be eligible to participate on the quota leasing exchange.

#### Offer prices

5. Producers may offer to lease quota in or lease quota out at any price.

#### Offer amounts

6. Producers may offer to lease quota within the limits established by Board Order 2005-05, or other limits as may be established by the Board in future orders, in increments of 0.1 kilograms of butterfat.

#### Offer forms

7. Producers offering to lease quota on the exchange shall only submit offers on a form provided by, or approved by, the Board.

#### Delivery of forms

8. Offers to lease quota must be received at the Board office by the close of business on the twenty-second day of the month prior to the lease month. The Board will accept a facsimile copy of an offer to lease quota on or prior to the close of business on the twenty-second day of the month, provided that the producer mails the original signed copy of the form to the Board within one day of the facsimile copy being sent.

## Weekends and holidays

9. Where the twenty-second day of a month falls on a weekend or a statutory holiday, the Board shall accept offers to lease quota up to the close of business on the next business day.

## Change or cancellation of offers

10. A producer may change or cancel an offer to lease quota provided that such change or cancellation is made in writing and the notice of change or cancellation is received at the Board office prior to the close of business on the twenty-second day of the month prior to the lease month, or the next business day if the twenty second day of the month falls on a weekend or a statutory holiday.

# Determination of market clearing price

- 11. Offers to lease quota shall be used to establish the lease-clearing price of the exchange in the following manner:
- (1) Offers to lease-out quota shall be accumulated based on the prices at which the quota is offered for lease-out, from the lowest to the highest price offered.
- (2) Offers to lease-in quota shall be accumulated based on the prices at which producers have bid for quota to lease in, from the highest price to the lowest bid price.
- (3) If no point is reached where the amount of quota offered for lease-out is equal to, or nearly equals, the amount of quota bid for lease-in, the exchange shall be deemed to have not cleared and no transactions shall take place on that exchange.

#### Selection process

- 12. Where the amount of quota offered for lease-out and the amount of quota bid for lease-in from other producers at the clearing price does not equal, the Board shall distribute the available quota in the following manner:
- (a) If the amount of quota offered for lease-out at or below the lease clearing price is greater than the amount of quota bid for lease-in at the lease clearing price, the Board shall establish leases for the quota offered for lease-out based on the order in which the offers to lease were received at the Board office.

(b) If the amount of quota bid for lease-in at or above the lease clearing price is greater than the amount of quota offered for lease-out at the lease clearing price, the amount of quota leased out shall be distributed in 0.1 kilograms of butterfat lots until the amount of quota offered for lease-out at or below the clearing price is fully distributed.

#### Clearing date

13. The Board shall establish the clearing price and clear the exchange on the twenty-seventh day of the month prior to the lease month except that where the twenty-seventh day of the month falls on a weekend or a statutory holiday the Board shall establish the clearing price on the evious business day.

#### Settlements

14. Producers offering to lease-in quota on an exchange shall provide the Board with a cheque, payable to the Board, that covers the full amount of the offer to lease, plus the appropriate service charge, dated no later than the twenty-second day of the month prior to the lease month.

#### Deposit of cheques

15. The Board shall deposit cheques for successful lease bids on the business day immediately following the day on which the exchange is run.

#### Settlements to

lessees

16. The Board shall issue settlements to lessees for overpayments on the tenth day of the lease month.

#### Settlements to

lessors

17. The Board shall issue settlements to lessors of quota, less applicable service charges, on the tenth day of the lease month.

## Adjustments to producer quotas

18. The Board shall debit lessor's quota with the amount of quota leased out and credit lessee's quota with the amount of quota leased in on the first day of the lease month. The leased quota shall revert to the lessor on the first day of the month following the lease month.

#### Service charges

19. Producers shall pay to the Board a service charge of \$3.00 for each successful offer to lease in or lease out quota and for each change in an offer as provided in section 10 of this order.

#### Default of Payment

20. In the event of default of payment for a quota lease, the Board shall require the lessee to remit guaranteed payment, by bank draft or comparable payment instrument, within two business days of notice to a lessee that his payment has been dishonoured. The payment remitted shall be sufficient to pay the cost of the lease and any related service charges levied by third parties.

#### Right of Offset

21. In the event of default of payment for a quota lease for which a producer is unable to provide payment within two business days, as outlined in section 20 of this Order, the Board shall retain the right to offset the indebtedness created by the default of payment against future revenues for milk sales of the lessee, and shall withhold the required funds from future milk sales payments to the lessee for settlement of the account

Unsuccessful offers 22. Producers who are not successful in leasing-in quota on an exchange shall have their cheques returned to them on the day the exchange clears.

#### NATURAL PRODUCTS MARKETING ACT POTATO MARKETING PLAN REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 5 July 2005.)

Pursuant to subsections 4(2) and (3) and section 29 of the *Natural Products Marketing Act* R.S.P.E.I. 1988, Cap. N-3, the Lieutenant Governor in Council, on the recommendation of the Prince Edward Island Marketing Council, made the following regulations:

# 1. The *Natural Products Marketing Act* Potato Marketing Plan Regulations (EC173/90) are amended by the revocation of subsection 9(1) and the substitution of the following:

Register of production units

**9.** (1) The Board shall maintain a register of production units by district which shall be available for inspection by registered producers without charge during normal business hours of the Board.

Idem

(1.1) The Board shall update the register of production units on June 30 each year.

Idem

(1.2) Notwithstanding subsection (1.1), the Board may update the register of production units at any other time during a year where a ballot vote is being taken among registered production units.

## 2. Section 11 of the regulations is revoked and the following substituted:

Composition of Board

- **11.** (1) The Board shall consist of 12 members, all of whom must be registered producers, and of the 12 members, four shall be seed producers, four shall be tablestock producers and four shall be processing producers, and
  - (a) one each of the seed, tablestock and processing producer members of the Board shall be residents of and elected from the West Prince District, consisting of that portion of the province that is situated to the west side of Route 166, running south from Bideford to Tyne Valley, then along Route 178 from Tyne Valley to Northam, then along Route 132 from Northam to Route 2, then in an easterly direction on Route 2 to Route 128, then in a southerly direction on Route 128 to Saint Chrysostome;
  - (b) one each of the seed, tablestock and processing producer members of the Board shall be residents of and elected from the Summerside District, consisting of that portion of the province situated between the east side of the West Prince District and a point starting from Browns Road along Route 238 to Route 6, then along

Route 6 to Stanley Bridge, then along Route 254 to Route 2, then along Route 2 to Route 231, then along Route 231 to Victoria;

- (c) one each of the seed, tablestock and processing producer members of the Board shall be residents of and elected from the Charlottetown District, consisting of that portion of the province situated between the east side of the Summerside District and a point starting at Savage Harbour along the Queens County Line to Route 214, then along Route 214 to Route 216, then along Route 216 to the Vernon River, then along the Vernon River to the Northumberland Strait; and
- (d) one each of the seed, tablestock and processing producer members of the Board shall be residents of and elected from the Montague-Souris District, consisting of that portion of the province situated on the east side of the Charlottetown District.
- (2) Notwithstanding subsection (1), members who were elected to the Transitional Board prior to the enactment of these regulations shall be deemed to be elected to represent the district in which they are registered in and resident of until the expiration of their terms.

(3) The Board shall hold elections for the districts in which a vacancy Idem occurs as a result of the enactment of these regulations within three months from the date of the enactment of these regulations, and the terms of office for those elected shall be staggered on a rotating basis so that each year the term of one member in each district expires.

#### 3. Section 12 of the regulations is revoked and the following substituted:

**12.** (1) Board members shall serve three-year terms.

Term of office

(2) Board members shall be elected on a three-year rotating basis with *Idem* the term of one board member in each district expiring each year.

#### 4. Section 16 of the regulations is amended

#### (a) by the revocation of subsection (4) and the substitution of the following:

- (4) The returning officer shall cause to be mailed to each registered Ballot producer in the district for which an election is being held
  - (a) a ballot which shall bear the name and classification of each candidate nominated to represent such district:
  - (b) a ballot envelope;
  - (c) a return addressed envelope; and
  - (d) voting instructions.

## (b) by the revocation of subsection (6) and the substitution of the following:

Counterfoil

- (6) Each ballot envelope shall have a counterfoil attached to the ballot envelope and the counterfoil shall contain the name of the production unit and the producer's name.
  - (c) by the revocation of subsection (12);
  - (d) by the revocation of subsection (13) and the substitution of the following:

Idem

- (13) A returning officer shall not count a ballot unless the returning officer has validated the counterfoil of the ballot envelope for the ballot.
  - (e) by the revocation of subsection (14) and the substitution of the following:

Counterfoil removed

- (14) All ballot envelopes shall have the counterfoil removed before being placed in the ballot box.
- 5. Section 18 of the regulations is revoked and the following substituted:

Re-election

- **18.** A registered producer who has served two full terms as a member of the Board is not eligible for re-election until the expiry of at least one full year after the completion of the registered producer's last term.'
- 6. These regulations come into force on July 16, 2005.

#### **EXPLANATORY NOTES**

**SECTION 1** authorizes the board to update the register of production units on June 30 each year, and at any other time during a year where a ballot vote is being taken among registered production units. Under the current regulations, the Board is required to maintain a continuous up-to-date register of production units.

**SECTION 2** increases the number of registered producers elected to the Board to 12 from 9, and re-defines the boundaries of the three districts described in the current regulations into four districts using the boundaries of the agricultural districts.

**SECTION 3** removes the initial term of the members on the Board since this section was redundant once the first election took place after enactment of the regulations.

**SECTION 4** more clearly defines the balloting process, including the documents mailed to registered producers. The section replaces the requirement to have the registered producer's signature on the

counterfoil, with the requirement that the counterfoil contain the name of the production unit and the producer's name. The section also revokes the requirement that the returning officer compare the signature of the registered producer on the counterfoil with the signature of the producer on the register of production units.

**SECTION 5** grants authority for members of the Board to serve two consecutive three-year terms in office. The current regulations only allow members of the Board to serve one full three-year term in office.

**SECTION 6** provides for the commencement of these regulations.

# PLANNING ACT SUBDIVISION AND DEVELOPMENT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 5 July 2005.)

- 1. Section 25 of the *Planning Act* Subdivision and Development Regulations (EC693/00) is amended by the addition of the following after subsection (3):
- (3.1) Subsection (3) does not apply to parcels of land along a portion Exception of a collector highway that is designated for infilling under regulations made under the *Roads Act*.
- 2. These regulations come into force on July 16, 2005.

#### **EXPLANATORY NOTES**

The amendment allows for exceptions to be made for parcels along collector highways that have been designated for infilling under the *Roads Act*.

# ROADS ACT HIGHWAY ACCESS REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 5 July 2005.)

Pursuant to subsection 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

- 1. Section 29 of the *Roads Act* Highway Access Regulations (EC580/95) is amended
  - (a) by renumbering section 29 as subsection 29(1); and
  - (b) by the addition of the following after subsection 29(1):

Idem

- (2) The Minister may authorize the placement of a new entrance way to a collector highway, or the change of use of an existing entrance way to a portion of a collector highway, in an area that has been designated for infilling in Schedule B-2.
- **2.** The regulations are amended by the revocation of the title "Schedule B, Collector Highways" and the substitution of the title "Schedule B-1, Collector Highways".
- 3. The regulations are amended by the addition of Schedule B-2, Infilling Areas, following Schedule B-1.

## SCHEDULE B-2 INFILLING AREAS

- 1. The following portions of collector highways are designated for infilling pursuant to subsection 29(2) of these regulations:
  - (1) On Route 25
    - (a) in the Community of York, that segment of highway which lies between the southern boundary of property number 641415 and the southern boundary of the Confederation Trail, a distance of 710 meters;
- 4. These regulations come into force on July 16, 2005.

#### **EXPLANATORY NOTE**

The amendment to the *Roads Act* Highway Access Regulations creates areas for infilling on Collector Highways and allows for the creation of new parcels of land in some communities located along this class of highway.
