Order: PB05-1 Effective: May 2, 2005

UNDER the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, the Prince Edward Island Potato Marketing Plan Regulations, and the *Agricultural Products Marketing Act* (Canada), the Prince Edward Island Potato Board makes the following order:

Potato Acreage Cap

Application

1. This order provides for the establishment and implementation of a potato acreage cap for potato crops planted in Prince Edward Island in 2005.

Definition

- In this order:
 - (a) "Act" means the Natural Products Marketing Act R.S.P.E.I. 1988, Cap. N-3;
 - (b) "Board" means the Prince Edward Island Potato Board established pursuant to the Act;
 - (c) "Cap" means the maximum acreage that a producer is authorized to plant in potatoes in 2005;
 - (d) "Institute" means the Prince Edward Island Potato Quality Institute incorporated under the Companies Act R.S.P.E.I. 1988, Cap. C14;
 - (e) "Person" includes individual, cooperative, partnership, or corporation;
 - (f) "Plan" means any plan established for the marketing of potatoes established and amended from time to time pursuant to the Act;
 - (g) "Plant Health Act" means the Plant Health Act R.S.P.E.I. 1988, Cap. P-9.1;
 - (h) "Potatoes" means potatoes produced in Prince Edward Island; and
 - "Producer" means a person engaged in the production of potatoes for his own account.

2005 Potato Acreage Cap

 The Board hereby establishes a Cap on acreages of potato crops planted in 2005 on the terms hereinafter set forth, for the objective of prohibiting an increase in the number of acres of land planted in potatoes in the province in 2005 over the acreage planted in 2004.

Calculation of Cap

4. The Cap for each producer shall consist of the average of that producer's acreage registered with the Institute pursuant to the Potatoes Regulations under the *Plant Health Act* for the years 2003 and 2004.

Prohibition

No Person shall plant potatoes in excess of the Cap applicable to such person calculated in accordance with Section 4. 620 **ROYAL GAZETTE** July 23, 2005

Transfer of Cap

- 6.(1) Subject to approval of the Board, a producer may transfer all or part of the producer's Cap to another producer for use in planting the potato crop acreage of that other producer for the 2005 crop year.
 - (2) Such transfer shall reduce the Cap of the transferring producer by the corresponding number of acres transferred to another producer in 2005.

fields

- Measurement of 7.(1) In measuring acreage planted by Producers for the purpose of determining compliance with this Order, the Board's employees or agents shall utilize Global Positioning System (GPS) technology and travel the perimeter of the planted area of fields in order to calculate the number of planted acres in each field, excluding, within such perimeter, unplanted areas due to wet field conditions, high slope, buffer zones, etc., measured on the same basis.
 - (2) The total of all fields measured for a producer will be used to determine whether the producer is in compliance with the producer's Cap.

Appeal

- 8.(1) A producer may appeal the producer's Cap by providing written notification to the Board of the nature of the appeal by May 31, 2005.
- (2) The Board will review the appeal, and advise the producer as to the Board's decision, within three weeks of receiving the complete information on the appeal.

Monitoring and Enforcement

- 9.(1) The Board or its authorized agents may inspect the 2005 potato crops of producers, whether growing or in storage.
- (2) The Board may access any and all information/documents deemed necessary by the Board for the implementation and enforcement of the Cap, including but not limited to producers' potato crop acreage information held by the Institute, the Canadian Food Inspection Agency, and/or the Prince Edward Island Department of Agriculture, Fisheries and Aquaculture.

No liability

The Board shall not be liable to any producers for any financial gain or loss which 10 may be incurred, projected or estimated as a result of the establishment and implementation of the Cap.

Penalties

- 11.(1) A Person who violates any provision of this order commits an offence punishable on summary conviction as set out in Section 25(1) of the Natural Products Marketing Act R.S.P.E.I. 1988, Cap. N-3.
 - (2) Where a violation of any provision continues for more than one day, the offender commits a separate offence for each day that the violation continues.
 - (3) The Board may seize and dispose of any potatoes marketed in contravention of this Order.
- This order comes into force on the 2nd day of May, 2005. Commencement 12.

1. This order provides for the implementation of a potato acreage buy down program for potato crops planted in 2005, and also provides for an increase in levies to fund the acreage buy down program.

Definitions

- 2. In this order:
- (a) "Act" means the Natural Products Marketing Act, R.S.P.E.I. 1988, Cap. N-3;
- (b) "Board" means the Prince Edward Island Potato Board established pursuant to the Act;
- (c) "Dealer" means a person who, on his own behalf or as an agent for or on behalf of any other person, is engaged in the marketing of potatoes in Canada and the United States, including Puerto Rico;
- (d) "Exporter" means a person who, on his own behalf or as an agent for or on behalf of any other person, is engaged in the marketing of potatoes outside of continental North America including Puerto Rico;
- (e) "Potatoes" means potatoes produced in Prince Edward Island;
- (f) "Processor" means a person who, on his own behalf or as an agent for or on behalf of any other person, is engaged in the processing of potatoes;
- (g) "Producer" means a person engaged in the production of potatoes for his own account; and
- (h) "Program" means the potato acreage buy down program established by this Order, whereby the Board will pay Two Hundred (\$200.00) Dollars per acre for each acre for which a Producer has applied to the Board to reduce acreage planted in 2005 below the maximum potato acreage such Producer is entitled to plant in 2005, and which has been accepted by the Board.

Acreage buy

down program

3. The Board hereby establishes an acreage buy down program for potato crops planted in 2005 on the terms hereinafter set forth, for the objective of reducing potato crop acreage in Prince Edward Island.

Conditions of program

4.(1) Producers wishing to participate in the Program may apply to the Board in a form prescribed by the Board to reduce potato crop acreage from the maximum permissible 2005 acreage of such Producer as communicated to the Producer by the Prince Edward

Island Potato Quality Institute Inc. and determined in accordance with Board Order PB05-1.

- (2) The application by the Producer must be received by the Board by no later than May 4, 2005.
- (3) The Board is not obliged to accept all or any acreage offered for participation in the Program.

Compensation for acreage reduction

- 5.(1) The maximum consideration paid for acreage accepted by the Board for participation in the Program shall be Two Hundred (\$200.00) Dollars per acre.
- (2) Payments shall be made by the Board to participants in the Program in two equal instalments, the first being paid on December 1, 2005, and the second being paid on February 1, 2006.

Prohibition

- 6.(1) A Producer whose application has been accepted in the Program may not use the accepted acreage as potato crop acreage for the 2005 crop year.
- (2) Acreage accepted in the Program may be transferred to another Producer for use as potato crop acreage for the 2005 crop year, provided that the Producer to whom the acreage has been transferred does not plant acreage in excess of that Producer's acreage cap as established pursuant to PB05-1 and that Producer's participation in the Program, if applicable.
- (3) In the event (i) a Producer participating in the Program plants potato acreage in excess of the acreage which the Producer is entitled to plant after participation in the Program, or (ii) a Producer to whom acreage which has been accepted in the Program has been transferred plants potatoes in such acreage in contravention of clause 6(2), the Producer planting the potatoes shall be liable to a penalty of Three Thousand (\$3,000.00) Dollars per excess acre planted, payable to the Board, and the Board or its authorized agents may enter upon the lands of the participant for the purpose of destroying the excess acreage.
- (4) The Board or its authorized agents may inspect the 2005 potato crops of participants in the Program, whether growing or in storage.
- (5) The Board may access any and all information/documents deemed necessary by the Board for the administration of the Program, including but not limited to participants' potato crop acreage information held by the Prince Edward Island Potato Quality Institute, the Canadian Food Inspection Agency, and/or the Prince Edward Island Department of Agriculture, Fisheries and Aquaculture.

No liability

7. The Board shall not be liable to any Producers for any financial gain or loss which may be incurred, projected or estimated as a result of a Producer's participation in, or rejection from, the Program.

Levies amendment

8.(1) Board order PB04-1 is hereby amended by the addition of the following as section 3.1:

For potatoes planted in the year 2005 only, the levies payable pursuant to subsection 3(1) shall be fourteen (\$0.14) cents per hundredweight, and the levies payable pursuant to subsection 3(2) shall be sixteen (\$0.16) cents per hundredweight.

(2) Board order PB04-2 is hereby amended by the addition of the following as section 5.1:

For potatoes planted in the year 2005 only, the levies payable pursuant to section 5 shall be six (\$0.06) cents per hundredweight.

(3) Board order PB04-3 is hereby amended by the addition of the following as section 6.1:

For potatoes planted in the year 2005 only, the levies payable pursuant to section 6 shall be six (\$0.06) cents per hundredweight.

9. This order shall apply to Dealers, Exporters, Processors and Producers.

- (j) "Program" means the potato acreage buy down program established by Order PB05-2, whereby the Board will pay Two Hundred (\$200.00) Dollars per acre for each acre for which a Producer has applied to the Board to reduce acreage planted in 2005 below the maximum potato acreage such Producer is entitled to plant in 2005, and which has been accepted by the Board.
- The Board hereby establishes the penalties which apply to any person who violates any provision of Board Orders pertaining to the maximum potato acreage which may be planted by Producers, including, without limitation, Board orders PB05-1 and PB05-2.

Amendments

- 4.(1) Board order PB05-1 is hereby amended by the deletion of section 10.
 - (2) Board order PB05-2 is hereby amended by the deletion of Section 6.(3).

Rectification Period

- 5.(1) Upon the Board or its agent determining that a Producer is in violation of a provision of a Board Order pertaining to the maximum potato acreage which may be planted by Producers, the Board or its agents shall give written notice of such violation to the Producer, whereupon the Producer shall have a period of 72 hours from the time of receipt of such notice within which to destroy potatoes planted in excess of the maximum potato acreage to which the Producer is entitled to plant in that crop year.
- (2) If the Board or its agents are satisfied that the Producer has destroyed the potatoes planted in excess of the maximum potato acreage to which the Producer is entitled to plant in that crop year within the 72 hour period following receipt of the notice referred to in clause 5(1), the Producer shall not be subject to any further penalty or overproduction levy with respect to such violation.

Penalties

- 6.(1) A Producer who violates any provision of a Board Order pertaining to the maximum potato acreage which may be planted by Producers commits an offence punishable on summary conviction as set out in Section 25(1) of the Natural Products Marketing Act R.S.P.E.I. 1988, Cap. N-3.
- (2) Where a violation of any provision continues for more than one day, the offender commits a separate offence for each day that the violation continues.
- (3) The Board or its authorized agents may enter upon the lands of a Producer for the purpose of destroying potatoes planted in excess of the maximum potato acreage to which the Producer is entitled to plant in that crop year.
- (4) In addition to the penalties prescribed in clauses 6(1) to 6(3), a Producer who violates any provision of a Board Order pertaining to the maximum potato acreage which may be planted by Producers shall be liable to pay to the Board an overproduction levy of \$1,250 for the first 0.5 hectares or portion thereof planted in violation, and \$2,500 per hectare for each additional hectare, or fraction thereof, which are planted in violation, to a maximum levy of \$25,000.
- (5) The Board may seize and dispose of any potatoes marketed in contravention of this Order.

Appeal

- 7.(1) A producer may appeal the Board's decision by serving notice of the appeal in writing to the Board within seven days of being notified of the violation.
- (2) The Board shall, within seven days of receiving the appeal, serve notice to the producer making the appeal of the date, time and place at which the appeal will be heard, which date will be within seven days of the notice being given by the Board and the Board shall render its decision on the appeal and serve notice on the producer making the appeal within seven days of the appeal being completed.
