PRINCE EDWARD ISLAND LANDS PROTECTION ACT EXEMPTION REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated December 13, 2005.)

Pursuant to clause 17(1)(b) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council made the following regulations:

- 1. Section 20 of the *Prince Edward Island Lands Protection Act* Exemption Regulations (EC368/88) is amended
 - (a) by renumbering section 20 as subsection 20(1); and
 - (b) by the addition of the following:
- (2) An interest to be acquired through purchase by McCain Produce Inc. of approximately 0.6 acres, which is the remnant of the entire parcel Inc. of Property No. 37333, located in Lot 5, Prince County, Prince Edward Island is exempt from the application of section 5 of the Act.

2. These regulations come into force on December 13, 2005.

EXPLANATORY NOTES

The exemption provides for the inclusion in the land holdings by the McCain group of companies of a small parcel of land that is the remnant of the entire parcel of Property No. 37333. The parcel to be included borders on 2 sides of the larger existing parcel that houses a fertilizer plant.

ROADS ACT HIGHWAY ACCESS REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated December 13, 2005.)

Pursuant to subsection 29(1) of the *Roads Act*, R.S.P.E.I. 1988, Cap. R-15 Council made the following regulations:

- 1. Clause 4(b) of the *Roads Act* Highway Access Regulations (EC580/95) is amended
 - (a) by the deletion of the words "; or" following subclause (i) and the substitution of a comma;
 - (b) by the deletion of the period following subclause (ii) and the substitution of a comma:
 - (c) by the deletion of the period following subclause (iii) and the substitution of the words ", or"; and
 - (d) by the addition of the following after clause (iii):
 - (iv) change of use of an existing entrance way to allow for the construction of a farm dwelling on the same parcel where a farm with complementary buildings exists prior to November 14, 2005.
- 2. These regulations come into force on December 13, 2005.

EXPLANATORY NOTE

This amendment allows for the change of use of an existing entrance way onto a highway to allow for the construction of a farm dwelling on a parcel which has complementary farm buildings, but does not include a dwelling.
