Pursuant to clause 17(1)(b) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council made the following regulations:

1. Section 20 of the *Prince Edward Island Lands Protection Act* Exemption Regulations (EC368/88) is amended

(a) by renumbering section 20 as subsection 20(1); and

(b) by the addition of the following:

(2) An interest to be acquired through purchase by McCain Produce Inc. of approximately 0.6 acres, which is the remnant of the entire parcel of Property No. 37333, located in Lot 5, Prince County, Prince Edward Island is exempt from the application of section 5 of the Act. McCain Produce Inc.
