FAMILY LAW ACT CHILD SUPPORT GUIDELINES REGULATIONS **AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 11 April 2006.)

Pursuant to section 61 of the Family Law Act R.S.P.E.I. 1988, Cap. F-2.1, Council made the following regulations:

- 1. Subsection 1(1) of the Family Law Act Child Support Guidelines Regulations (EC668/97) is amended
 - (a) by the deletion of the word "Guidelines" in that portion of the wording preceding clause (a) and the substitution of the word "regulations";
 - (b) by the revocation of clause (e);
 - (c) in clause (f),
 - (i) by the deletion of the words "a spouse as defined in clause 29(1)(b) of the Act and may include a "parent" as defined in clause 1(1)(e) of the Act" and the substitution of the words "a spouse as defined in clause 1(1)(g) of the Act and includes a "parent" as defined in clause 1(1)(e) of the Act", and
 - (ii) by the deletion of the semicolon and the substitution of a period;
 - (d) by the revocation of clause (g); and
 - (e) by renumbering subsection 1(1) as section 1.
- 2. Section 2 of the regulations is revoked and the following substituted:
- 2. The Federal Child Support Guidelines, subject to such modifications Adoption focused as are set out in these regulations, are adopted as the guidelines approach governing the making of orders for child support under the Act.

3. Section 3 of the regulations is amended by the deletion of the words ", "spouse", and "table" and the substitution of the words "and "spouse".

- 4. Subsection 4(2) of the regulations is amended by the revocation of Paragraph (c) and the substitution of the following:
 - (c) in the case of an order made before May 1, 1997, the coming into force of these regulations.
- 5. Section 5 of the regulations is revoked.
- 6. Schedule I of the regulations is revoked and Schedule I as set out in the Schedule to these regulations is substituted.
- 7. These regulations come into force on May 1, 2006.

SCHEDULE

SCHEDULE I

Child Support Tables

Adoption of Federal Child Support Tables

1. The Federal Child Support Tables set out in Schedule I to the Federal Child Support Guidelines are adopted pursuant to subsection 61(4) of the Act and form part of these regulations with the modifications set out in subsection (2).

EXPLANATORY NOTES

SECTION 1 amends some of the definitions in the regulations and replaces the word "Guidelines" with the word "regulations". It also deletes a definition of the term "Child Support Guidelines" which is not needed.

SECTION 2 clarifies that the Federal Child Support Guidelines, subject to such modifications as the regulations set out, are adopted as the guidelines governing the making of orders for child support under the Act.

SECTION 3 deletes a reference in the regulations to the word "table".

SECTIONS 4 deletes references to the term "Child Support Guidelines".

SECTION 5 revokes a provision that is inconsistent with the Federal Child Support Guidelines as adopted by these amendments.

SECTION 6 revokes the Child Support Tables set out in Schedule I of the regulations and adopts, in substitution, the Federal Child Support Tables.

SECTION 7 provides for the commencement of these regulations.
