## PRINCE EDWARD ISLAND LANDS PROTECTION ACT

## EXEMPTION REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated 15 August 2006.)

Pursuant to clause 17(1)(b) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council made the following regulations:

**1.** Subsection 1.1(2) of the *Prince Edward Island Lands Protection Act*, **Exemption Regulations (EC368/88) is amended by the deletion of the words** "in respect of the specific land holdings identified in the approval granted under subsection (6)".

2. These regulations come into force on 26 August 2006.

## **EXPLANATORY NOTES**

The amendment clarifies that the exemption applies to the aggregate land holding of an approved cooperative venture.
