# MUNICIPALITIES ACT TOWN OF KENSINGTON EXTENSION OF MUNICIPAL BOUNDARY (APPLICATION TO ANNEX APPROXIMATELY ONE HUNDRED AND TWENTY ACRES) APPROVED

Having under consideration an application from the Town of Kensington presented pursuant to section 12 of the *Municipalities Act* R.S.P.E.I. 1988, Cap. M-13 to extend its boundaries to include approximately one hundred and twenty (120) acres, being Provincial Property Nos. 78329, 79236, 914689, and 918771, for which no municipal government is provided under the said Act, Council having under consideration the recommendation of the Island Regulatory and Appeals Commission and under authority of subsection 14(2) of the aforesaid Act, approved the application and ordered that the boundaries of the Town of Kensington be extended to annex approximately one hundred and twenty (120) acres as aforesaid, effective 3 July 2007, in accordance with the said application, and as indicated on a plan filed in the Registry Office for Prince County by the Minister of Communities, Cultural Affairs and Labour pursuant to subsection 2(1) of the *Municipal Boundaries Act* R.S.P.E.I. 1988, Cap. M-11.
