#### AUXILIARY CONSERVATION OFFICER DESIGNATION

(pursuant to subsection 4(1) of the Wildlife Conservation Act, R.S.P.E.I. 1998, Cap. W-4.1)

Pursuant to the authority provided to me by subsection 4(1) of the Prince Edward Island *Wildlife Conservation Act*, R.S.P.E.I. 1998, Cap.
