(b) "Auction Barn" Means an Establishment at Which Cattle Are Auctioned to the Highest Bidder;

(c) "Cattle" Means Finished Beef Cattle Produced in Prince Edward Island and Sold for Slaughter;

(d) "Commodity Board" Means Prince Edward Island Cattle Producers;

(e) "Drover" Means a Person Who Buys Cattle from Producers for Resale to Slaughterhouses, to Producers or Through Auction Barns;

(f) "Producer" Means a Person in the Province of Prince Edward Island Engaged in the Production or Marketing of Cattle;

(g) "Slaughterhouse" Means Any Provincially or Federally Inspected Establishment for the Butchering or Processing of Cattle.

Levy

4. Every Producer Shall Pay to the Commodity Board a Levy of \$4.00 per Head on All Cattle Sold by the Producer to a Slaughterhouse.

Idem

5. Every producer shall pay to the commodity board a levy of \$4.00 per head on all cattle sold by the producer through an auction barn.

Idem

6. Every drover shall pay to the commodity board a levy of \$4.00 per head on all cattle sold by the drover to a slaughterhouse.

7. Every drover shall pay to the commodity board a levy of \$4.00 per head on all cattle sold by the drover through an auction barn.

Method of Payment

8. Each slaughterhouse and auction barn shall deduct the levy referred to in section 3 from the purchase price of each head of cattle and shall remit levies collected to the commodity board within 60 days after the date on which the levies were collected.

9. When requested to do so by the commodity board, every slaughterhouse and auction barn shall forward to the commodity board a statement of levy receipts.

HIGHWAY TRAFFIC ACT SEAT BELT REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated 23 October 2007.)

Pursuant to section 92 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

1. Section 1 of the *Highway Traffic Act* Seat Belt Regulations (EC275/87) is amended

(a) in clause (a), by the deletion of the words "children weighing less than nine kilograms (20 pounds)" and the substitution of the words "children weighing less than ten kilograms (22 pounds) or who are less than one year of age";

(b) in clause (b), by the deletion of the words "children weighing nine kilograms (20 pounds)" and the substitution of the words "children weighing ten kilograms (22 pounds)"; and

(c) by the revocation of clause (c) and the substitution of the following:

(c) children who

(i) weigh eighteen kilograms (40 pounds) or more;

(ii) are 9 years of age or less; and

(iii) are less than 145 centimetres (57 inches) tall,

are classified as pre-school to elementary grade children.

2. Section 4 of the regulations is amended

(a) by renumbering it as subsection 4(1);

(b) in subsection (1), by the deletion of the words "a pre-schooler shall be secured by the pelvic restraint system of a seat belt assembly or" and the substitution of the words "a pre-school to elementary grade child shall be secured in"; and

(c) by the addition of the following after subsection (1):

(2) Notwithstanding subsection (1), a pre-school to elementary grade Exceeds limit child who exceeds the weight limit for a booster seat of a type referred to in subsection (1), as prescribed by the manufacturer of a booster seat, is

not required to be secured in a booster seat but shall be required to be secured by a seat belt as defined in clause 92(1)(d) of the Act.

3. Section 6 of the regulations is amended by the deletion of the words "the toddler shall be secured in a lap belt if a seating position with a lap belt is available to that child" **and the substitution of the words** "the toddler shall be secured by a seat belt as defined in clause 92(1)(d) of the Act".

4. These regulations come into force on January 1, 2008.

EXPLANATORY NOTES

The amendment includes a new provision outlining the age, height and weight requirements for children using booster seats. The amendment also provides an update on infants in rearward-facing child restraint seats, and provides that for the casual and occasional transportation of toddlers, or for the transportation of toddlers in vehicles registered in a jurisdiction which does not require the use of child restraint systems, the toddler shall be secured in a seat belt as defined in the Act. The amendment is to come into force on January 1, 2008.
