### PRINCE EDWARD ISLAND POULTRY MEAT COMMODITY MARKETING BOARD

BOARD ORDER: PMCMB07-01 EFFECTIVE: November 23, 2007

Under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, the Poultry Meat Commodity Marketing Regulations and the Prince Edward Island Chicken Order made pursuant to the *Agricultural Products Marketing Act* (Canada), the Prince Edward Island Poultry Meat Commodity Marketing Board makes the following order:

#### PRINCE EDWARD ISLAND CHICKEN QUOTA ORDER

Application

1. This order applies to the control and regulation of the production and marketing of chicken in the Province of Prince Edward Island.

Interpretation

- 2. (1) The meaning of words herein shall be as defined herein or, if not defined, as in the *Natural Products Marketing Act* R.S.P.E.I. 1988, Cap. N-3 and the Prince Edward Island Poultry Meat Commodity Marketing Regulations.
  - (2) In this order:
    - (a) "Agency" means Chicken Farmers of Canada (CFC) created under the Farm Products Agencies Act (Canada).
    - (b) "Chicken" means a chicken of any class or parts thereof produced in the Province of Prince Edward Island but does not include a chicken that is:
      - (i) five months or older;
      - (ii) ten days or younger; or
      - (iii) used in egg production.
    - (c) "Board" means the Prince Edward Island Poultry Meat Commodity Marketing Board;
    - (d) "Processor" means any person engaged in the slaughtering of chicken;
    - (e) "Producer" means any person who raises chicken for processing, for sale to the public, or for use in products manufactured by him; and
    - (f) "Basic production quota" means a quota allocated by the Board to a producer in terms of kilograms of eviscerated poultry meat to be utilized by the Board as a base for annual production quota allocations to producers.

Exemption

3. A producer who produces and markets poultry meat from less than 500 chickens in a calendar year is exempt from this order.

Quotas property

of the board

4. Quota is the property of the board.

Commitment

to produce

5. Quota is not only a restriction on the amount to be produced, but is also a commitment by the quota holder to produce.

Transferability 8. Quota shall not be sold, rented, leased or transferred between producers, and shall revert to the board when a producer ceases operations, but may be re-issued to a

purchaser of the production unit at the discretion of the board.

Licenses 9. Licenses to market under a quota will be issued on a annual and/or periodic basis, both of which may be varied depending on the provincial allocation received from

Chicken Farmers of Canada.

Over production 10. Over production shall be subject to the penalties established by the Board and

ed weight 15. The conversion from live weight to eviscerated weight shall be as established by

Agriculture and Agri-Food Canada unless actual weights are available.

Producer requirements

Prohibition

16. (1) Producers and new producers applying for quota must satisfy the board that they

have, or will have within a reasonable period of time,

(b) adequate financial arrangements; and

  - (2) In this order:
    - (a) "Agency" means Chicken Farmers of Canada (CFC) created under the Farm Products Agencies Act (Canada);
    - (b) "Board" means the Prince Edward Island Poultry Meat Commodity Marketing Board;
    - (c) "chick" means a bird which is ten days or younger that will be raised as a chicken;
    - (d) "chicken" means a chicken of any class or parts thereof produced in the Province of Prince Edward Island but does not include a chicken that is:

      - (iii) used in egg production;
    - (e) "permit" means a permit issued by the Board authorizing a producer to purchase chicks;
    - (f) "producer" means any person who raises chicken for processing, for sale to the public, or for use in products manufactured by him.

Exemption

3. A producer who produces and markets poultry meat from less than 500 chickens in a calendar year is exempt from this order.

Prohibition

4. No producer shall purchase chicks without prior approval of the Board.

Eligibility

- 5. A producer shall not be entitled to purchase chicks if:
  - (a) the producer is not in possession of a quota or license issued by the Board;
  - (b) such purchase might result in the production and or marketing of chicken in excess of the producer's quota;
  - (c) the producer is in arrears in the payment of charges or levies imposed by the Board;
  - (d) the producer has failed to submit reports to the Board;
  - (e) the producer is unwilling to allow the Board or the Agency to count the number of chickens in the producer's production facilities;
  - (f) the producer is otherwise in violation of the Act, regulations or orders of the Board; and

(g) if the purchase of chicks, when placed in production would result in the province exceeding its provincial quota allocation.

Own chicks 6. When a producer raises his own chicks from eggs hatched by him, a purchase shall be

deemed to have occurred when the chicks are one-day old and the producer shall make an

application under paragraph 5 of the order seven days prior to hatching.

Form 7. Approval by the Board shall be in such form as may be prescribed by the Board.

Revocation 8. Board Order 84-5 dated December 18th 1984, is revoked.

  - (d) A license issued by the Board shall expire on the 31st day of December of the year of issue.
  - (e) Every license shall be issued subject to the following conditions:
    - (i) the licensee shall provide to the board such reports and information as the board may from time to time require;
    - (ii) the licensee shall permit the board, its employees or agents, to inspect the licensee's premises and records; and
    - (iii) the licensee shall at all times during the term of the license comply with all orders and regulations of the board.

#### Application for

license

5. Application for license shall be made in a form provided by the board and shall include such information that the Board deems necessary to properly assess the application.

#### Suspension, revocation

and refusal to

issue a license

- 6. (a) The Board may suspend, revoke or refuse to issue a license where the applicant or licensee is not qualified by experience, financial responsibility, or equipment, to engage properly in the business for which application is made or where the applicant or licensee has failed to observe, perform or carry out any condition of the license.
  - (b) To be eligible for a license, a producer must be certified under the On-Farm Food Safety Assurance Program adopted by the Board for poultry producers.
  - (c) The Board may grant a producer a conditional license where the producer has enrolled in the On-Farm Food Safety Assurance Program but has not yet been certified.
  - (d) Where the Board intends to suspend, revoke or refuse to issue a license, the Board shall give to the licensee by mail, addressed to him at his address recorded in the books of the Board, notice of its intention to suspend, revoke or not issue the license, as the case may be, and such notice shall fix a time of not less than 30 days from the mailing thereof for

the licensee to show cause why the license should not be suspended, revoked or not issued.
