** Under the Alberta Tobacco Tax Act and its Regulations, Alberta duty free shops may sell tobacco products (i.e. cigarettes and fine cut tobacco) **exempt of Alberta tax** only on "black stock" tobacco products sold to persons about to leave Canada. "Black stock" means tobacco products stamped in accordance with a federal statute or regulation to indicate that the duty has been paid but not stamped or marked in accordance with a provincial statute or regulation to indicate that they are intended for retail sale in a particular province or particular provinces.

The Alberta Tobacco Tax Act **prohibits** the purchase, possession, storage, sale or offer for sale of unstamped and unmarked tobacco products, or tobacco products marked for retail sale in another province, territory or country, by any retailer in Alberta.

The personal information that you provide on this form is collected under the authority of section 12.2 (1) of the Tobacco Tax Regulations and section 33(a) and (c) of the Freedom of Information and Protection of Privacy Act (RSA 2000).
