#### The Women's Institutes of Nova Scotia announce the results of our **Buy Local** Challenge Survey

From June through October 2006, Women's Institutes members from across Nova Scotia distributed the W.I. Buy Local Challenge Survey to the public. Members attended fairs, farmers' markets and many other public events to promote the 'buy local' theme while collecting more than 2400 surveys. The goal was not only to collect valuable data on the public's food buying behaviours, but also to encourage people to think about how purchasing local food benefits people's health, the economy, the environment and social well-being. If Nova Scotians want to see more local food products on grocery store shelves and on plates in restaurants, they have to 'Be Vocal and Buy Local'.

The majority of respondents were female, aged between 31-75. Two-thirds of the respondents had some form of post-secondary education. Income was fairly evenly distributed with one-third reporting an income of over \$60,000. Almost one half of

respondents lived in a community of under 2,000 people.

#### What Factors Influence the **Types of Food We Purchase?**

Survey respondents indicated that taste and nutritional value are the two most influential factors on the food they buy. Locally grown product was identified as the third most influential factor, followed by price, ease of preparation and finally, organic.

Several factors were considered under the following categories: sex, income, community size, education and age. Women consistently rated each factor higher than men, with the exception of organic. There was little difference by income level, although price was more of an issue for those earning less than \$40,000 per year.

Those living in smaller communities tended to report that whether food was locally grown had a larger influence on their food purchasing behaviour, whether food was organic had a smaller influence. As education level rose, respondents were less worried about the cost of food, or ease of preparation. They were also slightly more likely to consider whether food was organic.

Under the age category, it was found that as age increased, nutritional value and whether the product was locally grown became stronger influences on food buying behaviour.

#### What is 'Local'?

Over 90 per cent of respondents considered food grown in Nova Scotia to be local.

#### Where Can I Buy Local Foods?

Respondents believed the best places to buy local foods were from farmers' markets, directly from the farm, or small fruit and vegetable markets. Large grocery stores and family-style restaurants were listed next, followed distantly by convenience stores and fast-food restaurants.

#### Beliefs, Attitudes and **Propensity to Buy Locally Produced Food**

Respondents reported that they like to buy locally produced food whenever possible and that they do consider the place of origin when purchasing. The survey showed respondents strongly believed that buying local food is good for the local economy, that local food is fresher, buying local food helps the environment and that buying locally produced food means more money goes to the farmer. The survey also showed respondents felt that they only had little to moderate control over their ability to obtain local foods and in knowing whether or not the

food was grown locally.

Respondents strongly agreed that the government should promote buying locally produced food. They also indicated that they would buy more locally produced foods in grocery stores and restaurants if the foods/menu items were clearly marked with a logo.

Women's Institutes feels that the completion of this project and survey will be of benefit to the Nova Scotia agricultural and agri-food sector through the enhanced knowledge of consumers local food issues. The more savvy the consumer, the more benefits to the industry. Consumer purchasing power and sector knowledge is increasingly important to gauge as the public's thirst for knowledge about the food they are eating continues to grow and develop. It is clear - more emphasis on 'Buying Local' is needed.

# Maritime Shelterbelt Program Looking for Additional Demonstration Sites

The Maritime Shelterbelt Program is aiming to help hog and other livestock producers better understand the benefits of planting shelterbelts around livestock barns. Shelterbelts can serve a number of purposes, benefiting producers, their neighbors and the environment.

#### **Shelterbelt Benefits**

- Reduced energy costs
- Improved snow distribution
- Increased crop yields
- Reduced GHG emissions
- Increased biodiversity
- Reduced odour, dust and noise from farm

The Atlantic Swine Research
Partnership and the Canadian
Pork Council have been working
to provide shelterbelt training in
the Maritimes. Over the course of
the program, a number of
workshops have been held
instructing participants on all
aspects involved in establishing
and maintaining shelterbelts. As

part of the training, participants have designed six demonstration shelterbelts: two in Nova Scotia, two in New Brunswick and two in Prince Edward Island. One additional site is to be installed at the Atlantic Swine Research Partnership research barn in the spring of 2007. To date over 5500 m of shelterbelt, consisting of over 1800 trees have been planted as part of this program.

To facilitate future activities, a plastic mulch applicator, plastic mulch, brush mower and basic soil preparation, as well as tree maintenance equipment have been purchased. They are available for use by interested producers and agronomists.

Trained professionals throughout the Maritimes are available to design and assist with establishing your shelterbelt for FREE

The program is now providing support for establishing shelterbelts throughout the Maritimes. Farmers who are interested in shelterbelts for their farm properties can access funds through the National Farm Stewardship and Greencover Canada Programs, which will provide 50 per cent of the establishment costs up to a maximum of \$10,000. #### Canadian Agriculture Income Stabilization (CAIS) Program Processing and Payments

For the 2005 CAIS program year, 90 per cent of all applications have been processed. Processing for the 2006 program year is underway. Applications are processed on a first-come first-served basis. The earlier you submit your 2006 Harmonized Statement of Farming Activities, the sooner it will be processed. Please make sure your files are complete before submitting.

In regards to your Calculation of Benefits (COB). It is important to check the information in your COB for errors when you receive it. You have 90 days from the date on your COB to make adjustments and appeals to the CAIS Administration. If you require assistance, please call the Programs and Business Risk Management at 902-893-6510 or toll free 1-866-844-4276.

CAIS FEE deadline for the 2006 program year is April 30, 2007. The deadline to pay the fee amount was December 31, 2006 for the 2006 CAIS program year. If you have not paid the fee, you may still participate. Participants have until April 30, 2007 to pay with penalty (FEE + 20 percent). The fee is now owing if you did not officially opt out of the 2006 program year by September 30, 2006. You will not be able to participate in the 2006 program year if you do not pay your fee by April 30, 2007.

#### CAIS FEE deadline for the 2007 program year

For the 2007 program year, those who have previously participated will be enrolled automatically however, Options Notices (ON's) (including the fee requirement) have not been mailed out yet. You will be informed when these will be available and any other updates pertaining to the 2007 program year.

# Farmers of the Future

Most people would think 50 young farmers released in Ottawa for a four-day conference would be a recipe for disaster, but the truth is quite the opposite. Last month, the Canadian Young Farmers Forum (CYFF) held their Annual General Meeting and Workshop for young farmers across Canada. Each of the 10 provinces as well as the Yukon Territory were represented at the CYFF conference. Producers at the conference ranged from 18 to 40 and farms as small as four acres up to 17,000 acres and encompassed most commodities.

CYFF is a national group that represents the voices of young farmers across the country. This year marks the 10th anniversary of the group. CYFF has acted as an information source for policy makers, provincially and federally, on issues concerning many young farmers in Canada.

CYFF is not a lobby group, and thus has gained a tremendous amount of respect from all levels of government. During the 2007 meeting, the group met with both the Federal Deputy Minister of Agriculture and the Federal Standing Committee on Agriculture. These round table discussions allowed the voice of young farmers to be heard and provide feedback on issues they are facing.

The CYFF has also been asked for their input into all the APF II consultations and had representation at the Uruguay International Federation of Agriculture Young Farmers Committee meetings.

CYFF's mandate is to foster and build skills of young farmers to become the next agriculture leaders in their community as well as their country. This is accomplished through networking and the free exchange of ideas among the participants. The CYFF also provides workshops on topics

and challenges that young farmers face in agriculture today. These include succession planning, financial planning, and many others. By introducing and discussing these issues, young farmers become more informed of ways to deal with and overcome these challenges to increase their success.

The roots of the CYFF are established at the provincial and local levels. Nova Scotia is currently building and developing a young farmers program affiliated with this national organization. The goal of this group will be much the same as that of the CYFF; to create an atmosphere that fosters and develops the next generation of agriculture leaders.

#### Amendments to the Livestock Health Services Act

Acting Agriculture Minister Ron Chisholm introduced amendments to the *Livestock Health Services Act* on March 19 in the legislature.

The proposed amendment will give the minister of agriculture authority to make changes to the travel and service fees paid to veterinarians who look after large farm animals.

"Veterinarians provide a key service to farmers who are not able to transport their animals to veterinarian clinics," said Mr. Chisholm. "We want to make sure that they are adequately compensated for this service."

The proposed legislation does not affect the fees that are charged by veterinarians for their services.

# Local Doctoral Student receives 2007 Canadian Meat Council Associate Members Scholarship

Rob Michitsch, a doctoral student at Dalhousie University and the Nova Scotia Agricultural College (NSAC), was recently awarded the 2007 Canadian Meat Council (CMC) Associate Members Scholarship. The scholarship is intended to promote quality education and development of meat science research in Canada. He recently traveled to Vancouver, British Columbia to attend the Canadian Meat Science Association (CMSA) Technical Symposium, where he received the award and gave a presentation on his doctoral research to government and industry leaders.

Mr. Michitsch's research is part of a project titled "Management of Slaughterhouse Waste Materials" through NSAC and the Nova Scotia Federation of Agriculture being led by Dr. Rob Gordon, Canada Research Chair and Director of Research at NSAC. The research is part of an industry initiative with partial funding provided by Agriculture and Agri-Food Canada through Agri-Futures Nova Scotia and the New Brunswick Agricultural Council/Conseil Agricole du Nouveau-Brunswick.

Mr. Michitsch is researching onfarm composting of both livestock mortalities and slaughterhouse waste materials. This is an alternative method to traditional rendering and burial. The management and disposal of these materials (carcasses and offal) is a necessary aspect of animal production, which needs to be quick, cost-effective and safe, especially to reduce the risk of disease.

The potential of this management practice for additional waste treatment opportunities has recently been identified for the slaughterhouse industry. "We already know that biopiles work" says Mr. Michitsch. "However, there is little research on the persistence and movement of bacterial and viral pathogens in these biopiles." Given the recent CFIA ban on specified risk materials (SRM's) and deadstock in animal feed, pet food and fertilizers, on-farm composting is especially attractive since regulatory permits are not required for safe disposal of these materials on the farm of origin.

Mr. Rick Williams, Executive Director of Agri-futures Nova Scotia, agrees. "This topic is on the forefront of issues currently being examined by the meat industry. It is exciting to see an industry initiative presented at a national arena." As the sole recipient of the scholarship, Mr. Michitsch says, "I feel very fortunate to have received this scholarship and to be able to present Maritime-focused research at a national symposium."

#### NSAC Graduate Student is Recipient of ECO Canada Student Award 2007

Julie Bailey, a graduate student at Nova Scotia Agricultural College (NSAC), has been selected for one of 15 Environmental Careers Organization (ECO) Canada Student Awards. Julie will receive a \$1,000 prize and the opportunity to showcase her poster at Americana 2007 (<a href="www.americana.org">www.americana.org</a>), a biennial conference on environmental business held in Montreal, Quebec.

Julie is currently working on a Masters Degree through Dalhousie University and NSAC. She is conducting her research under the supervision of Dr. Rob Gordon, Canada Research Chair and Director of Research at NSAC. Julie is from Earltown, Nova Scotia and has a Bachelor of Engineering in Chemical Engineering from the Technical University of Nova Scotia. She is also the recipient of several scholarships, including a prestigious Natural Sciences and **Engineering Research Council** (NSERC) Canada Graduate Scholarship, the Robert P. Longley Scholarship and the **Canard Conservation** Scholarship.

Julie's research utilizes a survey to identify the interest in and potential for energy efficiency upgrades, renewable energy alternatives and energy audits for Nova Scotia farmers. The primary objectives are to gain baseline data on a cross section of farms with respect to energy usage and energy efficiency renewable energy options currently in use; to gain awareness of farmers' desire and ability for implementing energy efficiency or renewable upgrades, and to determine if farmers would be interested in participating in an energy audit program and the scope of the program.

#### CFIA ADVISES NOT TO USE CHEMICALLY-TREATED WOOD NEAR LIVESTOCK FEED AND ANIMALS

The Canadian Food Inspection Agency (CFIA) is advising livestock producers across Canada not to use chemically-treated wood structures near livestock feed or food-producing animals because they can transfer potentially harmful levels of chemicals into animal products, such as meat, milk and eggs.

As part of the CFIA's residue monitoring program, dioxin levels higher than background were detected in raw milk from two British Columbia dairy operations. The dioxin was found at levels that are not considered an immediate health risk by Health Canada. The levels found did, however, trigger follow-up action to identify and eliminate the source of contamination, in line with Canada's approach to managing dioxin in the food supply. Dioxins are released into the environment through natural and industrial processes and are commonly found in low levels throughout the food chain around the world.

The CFIA and the Province of British Columbia are collaborating on this issue. The CFIA is also working with other provinces and territories to ensure this advice reaches all livestock producers. The investigation indicated that chemically-treated wood used in some silage bunkers (animal feed containers) may, in large part, be the source of the dioxin detected. Exposure to wood treated with chemicals,

such as pentachlorophenol (PCP), has been shown to result in higher than background levels of dioxins in livestock feed, which can then transfer into animal products. Further follow-up after precautionary measures were implemented indicated lowered levels of dioxin.

Producers should ensure that livestock feed is not stored where it can come into direct contact with chemically-treated wood structures. Animals should also not be allowed to come into contact with chemically-treated wood, including sawdust or shavings that could be used for bedding. At a minimum, bunker silos containing this wood should be lined with a plastic tarp and untreated lumber. Gloves should be worn when handling any treated wood and scraps must be disposed of in accordance with provincial/territorial and municipal regulations. Spring is a busy time on many farms. With the many tasks that have to be done, the opportunity for accidents increases. In addition to the many spring jobs that have to be done, make time to ensure your farm is safe for you and your family. Now is a good time to:

- Check fencing around ponds and manure storages.
- Ensure PTO guards are in place.
- Take extra precautions to guard against manure gas in liquid manure storages.
- Check your farm first aid kit(s) to ensure they are fully stocked and ready for use.
- Make sure your fire extinguishers are full and in place on machinery and in buildings.
- Make sure your slow moving vehicle signs are on equipment and can be seen.

#### Preparing for Safety

Spring activities will soon start on the farm. Are you ready? Is your new employee ready? Do you have an up to date First aid course, Remote Access Plan, and Environmental.

First aid courses expire after three years. There should be at least one member on the farm with these qualifications, plus first aid kits available. A visible map of the farm, showing field locations is helpful if you ever have to call 911. You are lying in field 14, it would be helpful if someone could find it. Bringing your staff up to speed about safety at the beginning (ie ear protection, eye protection, are they capable of operating a power saw, tractor, basic WHIMIS training, etc.) is important.

#### **Environmental Awareness**

Often new employees are keen to spread manure and perform other spring activities. Make sure they are aware of the set backs from brooks, wells, etc. before they start spreading on a particular field. Transporting equipment on the road takes extra caution as well, as does increased time to stop large manure tankers. Transporting wide loads or unstable loads such as too many round bales on a wagon, can be dangerous. Let's have a safe farm season and make it the first thing on the list this spring.

#### **Buying Local**

There is a tremendous variety of local products available in our area. Recently lots of discussion has focused on increasing the marketing and demand for local produce. Programs have been announced to encourage these opportunities. Producers should consider how they may take advantage of marketing products locally and what infrastructure is needed to create this.

Is there interest in branding a local beef, fresh produce, selling to St.Francis Xavier University, Farmers Market, growing - organic food, etc. Ideas and leadership are certainly needed to transition the agricultural sector. Who is up for the challenge?
