# **Reporting incidents and injuries**

At WorkSafeBC, we understand that a workplace injury can be extremely stressful — both for you and your workers. So we want to make the process of reporting an injury as simple as possible. When you report the injury online, through Employer's Incident and Injury Report (EIIR), you can take advantage of many benefits that are not possible through more conventional methods, like mail or fax.

To get started, go to WorkSafeBC.com and select "Report an injury or illness."

### Here are some of the features:

**No delays:** If you're an employer, the *Workers Compensation Act* requires you to submit an injury report within three days of being notified of an injury to one of your workers. When you submit your report online we receive it immediately — helping you avoid delays sometimes associated with mailing or faxing paper forms.

**Streamline your report:** As you complete the report, EIIR tailors the questions about the injury based on your previous answers.

**Saving and updating:** If you don't have all the information at your fingertips, don't worry. You can save your report and complete it later. If you need to make changes to your information after submission, simply log on again, enter your new information, and resubmit your report.

**Online help:** Online wizards, pull-down menus, help screens, and FAQs guide you through the report, making the process of completing it simpler, quicker, and easier.

**Follow the status of the claim:** After you have submitted your report, follow the status of the claim — from the first payment to return-to-work — simply by logging on to WorkSafeBC.com.

**Only one form per incident:** If several workers were injured during the incident, you do not have to submit separate reports for each worker as you would with paper forms.

**Accurate and secure:** Error-checking features help you ensure your information is accurate before you submit it. Also, your reports are stored securely and access to them is controlled by your organization.


