Changes to User Fees and Government Charges

FISCAL YEAR 2007–2008

The Government of Nova Scotia will be increasing most user fees and government charges by 6.8 per cent in 2007–2008. The 6.8 per cent increase is tied to the CPI increase.

The last government-wide increase to user fees and government charges, was in April 2004. The current increases will provide additional revenue to help cover the overall rising costs of government programs and services.

Most fees will increase on April 1, 2007. Some fees will increase on dates determined by the individual departments.

This document summarizes and lists the various fees and charges that are increasing and the revenue impact by department. The fee listing is provided for the convenience of readers. For the specifics of fee changes, please refer to the official regulatory and legislative amendments.
