## FAC Tribunal Members - Biographies - as at December 4, 2007

## **ALAN ANDISON, CHAIR**

Alan Andison obtained a B.A. in History in 1974 from Simon Fraser University and a LL.B. in 1985 from UVIC. Mr. Andison was called to the Bar in 1986. Mr. Andison has experience in the areas of administrative, environmental, forestry and natural resources law. He has held a variety positions with the BC public service including terms with the Office of the Ombudsman, the Human Rights Council and the Ministry of Environment, Lands and Parks. Mr. Andison was appointed Executive Director and General Counsel to the Environmental Appeal Board and the Forest Appeals Commission in 1995. He was appointed Chair of the Board and the Commission on July 27, 2000.

#### SUSAN BEACH

Susan L. Beach has been litigator in criminal and civil courts for 15 years. She has complex trial and tribunal experience, in particular involving expert testimony. She practiced for 10 years in the area of recovery of wildland fire suppression costs and property and timber loss arising from wildland fires. Ms. Beach is also a qualified mediator. #### **BRUCE DEVITT**

Bruce has been a member of the Provincial Forest Appeals Commission since 1996 and the Environmental Appeal Board since 2003.

He graduated from the University of BC with a B.Sc. Degree in Forestry in 1957. Following graduation he practiced as a professional forester with the BC Forest Service in reforestation and in 1972 he joined Pacific Logging Ltd. After 18 years of industrial forest management Mr. Devitt retired in 1991 as Chief Forester for Canadian Pacific Forest Products Limited to become executive vice-president of the BC Professional Foresters Association. He retired from that position in 1995 to join private practice. He co-authored "Forest Practice, Policy and the Profession", a 50 year history of professional forestry in BC in 1998.

He was made a life member of his professional association in 2004 after 47 years of practice. Also after serving 15 years he retired as a director of the Pacific Regeneration Technologies Management Inc. in 2002.

Over the years he has been active in his profession and community affairs. He has been a chair of the local school board, chair of a Regional District a member of a hospital board and served on many National and Provincial professional committees. He was president of the Canadian Institute of Forestry in 1982 and received recognition from his fellow foresters in 1983 when he received the Distinguished Foresters Award. He is also holder of the Western Forestry Lifetime Achievement Award (1991) and the Canadian Forestry Achievement Award (1995).

Between 1999 and 2005 he was a Parks and Recreation commissioner and vice-chair of that organization for Esquimalt. In that capacity he championed and chaired the various committees charged with the revitalization of Esquimalt's Recreation Centre for which he received "The 2005 Canadian Parks and Recreation Association Award of Merit."
