CHAPTER C-4.1

CHARLOTTETOWN AREA MUNICIPALITIES ACT

TRANSITIONAL REGULATIONS (OATH OF OFFICE)

Pursuant to section 72 of the *Charlottetown Area Municipalities Act*, R.S.P.E.I. 1988, Cap. C-4.1, Council made the following regulations:

1. The mayor and councilors elect shall before taking office take an oath Oath of office of office before a commissioner for taking affidavits in the following form

OATH OF OFFICE

I,, do solemnly swear that I am duly qualified as required by law
for the office of Mayor/Councillor (as the case may be) of the City/Town of
to which I have been elected and that I will diligently,
faithfully, and impartially and to the best of my ability discharge the several duties
which appertain to the said office while I hold same. So help me God.
