CHAPTER F-2.1

FAMILY LAW ACT

CHILD SUPPORT GUIDELINES REGULATIONS

Pursuant to section 61 of the Family Law Act R.S.P.E.I. 1988, Cap. F-2.1, Council made the following regulations:

1. In these regulations

Definitions

Act

- (a) "Act" means the Family Law Act R.S.P.E.I. 1988, Cap. F-2.1;
- (b) "child" includes a child as defined in clause 1(1)(a) of the Act; child

- (c) "Federal Guidelines" means the Federal Child Support Federal Guidelines Guidelines established by regulation pursuant to section 26.1 of the Divorce Act (Canada), as amended from time to time;
- (d) "order assignee" includes a person or agency described under order assignee subsection 33(3) of the Act;
- (e) revoked by EC208/06;

Child Support

- (f) "spouse" includes a spouse as defined in clause 1(1)(g) of the Act spouse and includes a "parent" as defined in clause 1(1)(e) of the Act as one who has demonstrated a settled intention to treat a child as a child of his or her family, except under an arrangement where the child is placed for valuable consideration in a foster home by a person having lawful custody.
- (g) revoked by EC208/06. (EC668/97; 208/06)

2. The Federal Child Support Guidelines, subject to such modifications Adoption focused as are set out in these regulations, are adopted as the guidelines governing the making of orders for child support under the Act. (EC668/97; 208/06)

3. The definitions of "child", "order assignee", and "spouse" found in Definitions, section 2 of the Federal Guidelines are replaced by the definitions found replaced in section 1 of these regulations. (EC668/97; 208/06)

4. (1) In section 14 of the Federal Guidelines, the words "For the Words substituted purposes of subsection 17(4) of the Act, any one of the following constitutes a change of circumstances" shall be read "For the purposes of section 37 of the Family Law Act R.S.P.E.I. 1988, Cap. F-2.1 any one of the following constitutes a change of circumstances."

(2) Paragraph 14(c) of the Federal Guidelines shall be read as follows:
(c) in the case of an order made before May 1, 1997, the coming into force of these regulations. (EC668/97; 208/06)

5. Revoked by EC208/06. (EC668/97; 208/06)

6. Section 26 of the Federal Guidelines applies only where the Minister has designated a child support service for the purposes of that section. (EC668/97)

Child Support Tables

1. The Federal Child Support Tables set out in Schedule I to the Federal Adoption of Federal Child Support Guidelines are adopted pursuant to subsection 61(4) of the Child Support Act and form part of these regulations with the modifications set out in subsection (2).
